- 4. That Seventy percent of the amounts realized by Society /Promoter for the Real estate project from the allottees/ Shareholders, from time to time, shall be deposited in a separate account to be maintained in a Scheduled Bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account to cover the cost of the project shall be withdrawn by the Society/ Promoter in proportion to the percentage of completion of the project.
- 6. That the amount from the separate account shall be withdrawn by the Society/ Promoter after it is certified by an engineer, and architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That the Society / Promoter shall get the account audited within six months after the end of every financial year by a Chartered accountant in practice and shall produce a statement of account duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion of the percentage of completion of the project.
- 8. That the Society / Promoter shall take all the pending approvals on time, from the competent authorities.
- That the Society / Promoters has furnished, to the best extent, such other
  documents as have been prescribed by the Act and the Rules as may be amended
  from time to time.
- 10. That the Society / Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
