- 1. The particular of the land of aforesaid Affordable Residential Plotted Colony under DDJAY is to be set up, is enclosed.
- 2. The License is granted subject to the following terms and conditions:
 - a) That the licencee shall lay the Affordable Plotted Colony in confirmation to the approved layout plan and development works will be executed in accordance to the designs and specifications shown in the approved plans.
 - b) That the licencee shall abide by the Deen Dayal Jan Awas Yojna policy dated 08.02.2016, subsequent amendments from time to time and other direction given by the Director from time to time to execute the project.
 - c) That the conditions of the agreements already executed are duly fulfilled and the provisions of Haryana Development and Regulation of Urban Areas Act, 1975 and the Rules 1976 made there under are duly complied with.
 - d) That the licencee will pay the infrastructure Development charges amounting to Rs. 1,26,36,505/- @ Rs.281 25/- per sq m for the plotted area and Rs. 562.50/- for the commercial component in two equal installments. First installment will be due within 60 days of grant of licence and second installment within 6 months of grant of licence failing which 18% per annum interest will be liable for the delayed period.

That the licencee shall maintain and upkeep of all roads, open spaces, public park and public health services for a period of five years from the date of issue of the completion certificate unless earlier relieved of this responsibility and thereupon to transfer all such roads, open spaces, public parks and public health services free of cost to the Govt. or the local authority, as the case may be, in accordance with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.

- f) That the licencee shall construct 18/24/30 m wide internal circulation road forming part of licenced area at your own costs and transfer the same free of cost to the Government within a period of 30 days from the date of approval of zoning plan.
- g) That area under the sector roads and restricted belt/green belt, if any, which forms part of licenced area in lieu of which benefit to the extent

permissible as per policy towards FAR is being granted, shall be transferred free of cost to the Govt. within a period of 30 days from the date of approval of zoning plan.

- h) That the licencee shall integrate the services with Haryana Shehari Vikas Pradhikaran services as and when made available.
- i) That the licencee shall transfer 10% area of the licenced colony free of cost to the Government for provision of community facilities within a period of 30 days from the date of approval of zoning plan. Alternately, you shall have an option to develop such area on your own or through third party subject to the conditions mentioned at clause 4(j) in policy dated 25.08.2022.
- j) That the licencee shall understand that the development/construction cost of 24 m/18 m major internal roads is not included in the EDC rates and they shall pay the proportionate cost for acquisition of land, if any, alongwith the construction cost of 24 m/18 m wide major internal roads as and when finalized and demanded by the Department.
- k) That the licencee shall make arrangements for water supply, sewerage, drainage etc to the satisfaction of DGTCP till these services are made available from External Infrastructure to be laid by Haryana Shahari Vikas Pradhikaran.
- That you shall obtain clearance from competent authority, if required under Punjab Land Preservation Act, 1900 and any other clearance required under any other law.
- m) That the rain water harvesting system shall be provided as per Central Ground Water Authority Norms/Haryana Govt. notification as applicable.
- n) That the licencee shall use only LED fitting for internal lighting as well as campus lighting.
- o) That the licencee shall convey the 'Ultimate Power Load Requirement' of the project to the concerned power utility, with a copy to the Director, within two months period from the date of grant of licence to enable provision of site in licenced land for Transformers/Switching Stations/Electric Sub Stations as per the norms prescribed by the power utility in the zoning plan of the project.
- p) That it will be made clear at the time of booking of plots/commercial space that specified rates include or do not include EDC. In case of not inclusion of EDC in the booking rates, then it may be specified that same are to be charged separately as per rate fixed by the Govt. The licencee shall also provide detail of calculation of EDC per Sqm/per Sft to the allottees while raising such demand from the plot owners.

- q) That the licencee shall keep pace of development at-least in accordance with visuo 3 mot with sale agreement executed with the buyers of the plots as and when methods server scheme is launched.
- r) That the licencee shall arrange power connection from UHBVNL/DHBVNL for electrification of the colony and shall install the electricity distribution infrastructure as per the peak load requirement of the colony for which licencee shall get the electrical (distribution) service plan/estimates approved from the agency responsible for installation of external electric

services i.e. UHBVNL/DHBVNL and complete the same before obtaining completion certificate for the colony.

- That the licencee shall complete the project within seven years (5+2 years) s) from date of grant of licence as per clause 1(ii) of the policy notified on 01.04.2016.
- That no clubbing of residential plots for approval of integrated zoning plan t) of two adjoining plots under same ownership shall be permitted.
- That the licencee will pay the labour cess as per policy instructions issued u) by Haryana Government vide Memo No. Misc. 2057-5/25/2008/2TCP dated 25.02.2010.
- That the licencee shall submit compliance of Rule 24, 26, 27 & 28 of Rules v) 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, and shall inform account number and full particulars of the scheduled bank wherein licencee have to deposit seventy percentum of the amount received from the plot holders for meeting the cost of Internal Development Works in the colony.

In case of any violation of the provisions of said statutes, you shall be liable for penal action by Haryana State Pollution Control Board or any other Authority Administering the said Acts.
- That the licencee shall follow the provisions of the Real Estate (Regulations V) and Development) Act, 2016 and Rules framed there under shall be followed by the applicant in letter and spirit.
- That the licencee shall get re-alignment of the 132KV & 33KV Lines passing z)through the site, before approval of the zoning plan. Otherwise the licencee will revise the layout plan by providing requisite ROW of 132 KV & 33 KV HT lines.
