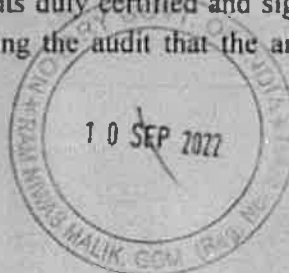

Affidavit cum Declaration of M/s Rose Building Solutions Private Limited having its office at 13th Floor, Dr. Gopal Das Bhawan, 28 Barakhamba Road, New Delhi 110001 of the Proposed Residential Floors (DDJAY) "Signature Global City 37D II (2)" by Mr. Sanjay Kumar Varshney, Mr. Manish Garg, & Mr. Anurag Srivastava duly authorized by the promoter of the proposed project, vide its/his/their authorization dated 25th May, 21.

We, M/s. Rose Building Solutions Private Limited do hereby solemnly declare, undertake and state as under:

1. That M/s Rose Building Solutions Private Limited (Developer) in collaboration with M/s Lalwani Brothers Buildcon LLP and M/s Lalwani Brothers Buildcon LLP has a legal title to the land admeasuring 1.42 acres on which the development of the project is proposed and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
2. That at present the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by promoter is 28/02/2026.
4. That seventy per cent of the amounts realised by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

 9. That M/s Rose Building Solutions Private Limited has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.


