- 3. That the time period within which the Phase 2 of the La Regencia Project shall be completed by the Promoter is December, 2019.
- 4. That seventy per cent of the amounts realised by the Promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the Promoter in proportion to the percentage of completion of the Project.
- 6. That the amounts from the separate account shall be withdrawn by the Promoter after it is certified by an engineer, an architect and a the percentage of completion of the project.
