- wn & Country Planning d) That the developer shall deposit the balance amount of External Development Charges of Rs. 664.00636 lacs in equal 6 half yearly installment with interest as per policy dated 05.12.2018 (may be seen on website www.tcpharyana.gov.in)
  - e) That the conditions of the agreements already executed are duly fulfilled and the provisions of Haryana Development and Regulation of Urban Areas Act, 1975 and the Rules 1976 made there under are duly complied with.
  - f) That the developer shall maintain and upkeep of all roads, open spaces, public park and public health services for a period of five years from the date of issue of the completion certificate unless earlier relieved of this responsibility and thereupon to

transfer all such roads, open spaces, public parks and public health services to the Govt. or the local authority, as the case may be, in accordance with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.

In case of not inclusion of EDC / SIDC in the booking rates, then it may be specified that same are to be charged separately as per rate fixed by the Govt. - u) That the developer shall keep pace of development at-least in accordance with sale agreement executed with the buyers of the plots as and when scheme is launched.
