I, Nisha Rathee Authorized Signatory of the Promoter Company of the proposed project do hereby solemnly declare, undertake and state under:

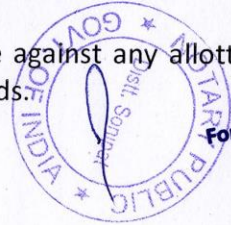
1. That the promoter has a legal title to the land on which the development of the project is proposed.
