Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 10.10.2022.

Item No. 187.15

Exemption for registration of Housing Board Haryana as a promoter for its ongoing and future projects under the provisions of Haryana Real Estate (Regulation & Development) Rules, 2017.

Housing Board Haryana vide their letter dated 19.07.2022 and 23.08.2022 has sought clarification from the Authority that whether the part of the project on which the Housing Board Haryana is carrying out the construction is required to be separately registered or not, as construction of these flats is earried out on a part of the whole licensed colonies.

The matter was considered by the Authority in its meeting hold on 28.09.2022, wherein the Authority had observed that:

The definition of the expression "promoter" has been given in Sub Section (zk) of Section 2 of the Act as reproduced below:

## Promoter means,-

(i) a person who constructs or causes to be constructed an independent building or a building consisting of apartments, or converts an existing building or a part thereof into apartments, for the purpose of selling all or some of the apartments to other persons and includes his assignces, or

tiii) any development authority or any other public body in respect of allottees of— (a) buildings or apartments, as the case may be, constructed by such authority or body on lands owned by them or placed at their disposal by the Government;

(iv) an open State level co-operative housing ferance sweets which constraints of other primary co-operative housing society which constraints of other pals or



buildings for its Members or in respect of the allottees of such apartments or buildings.

The Authority had also taken a similar view in the case of HSVP and HSHDC whereby it was observed that the projects being undertaken by both the Authorities are registrable. The same applies to Housing Board Haryana.

Housing board may be informed accordingly and be asked to comply with the provisions of Section-3 of the RERA Act and Rules & Regulations made thereunder.
