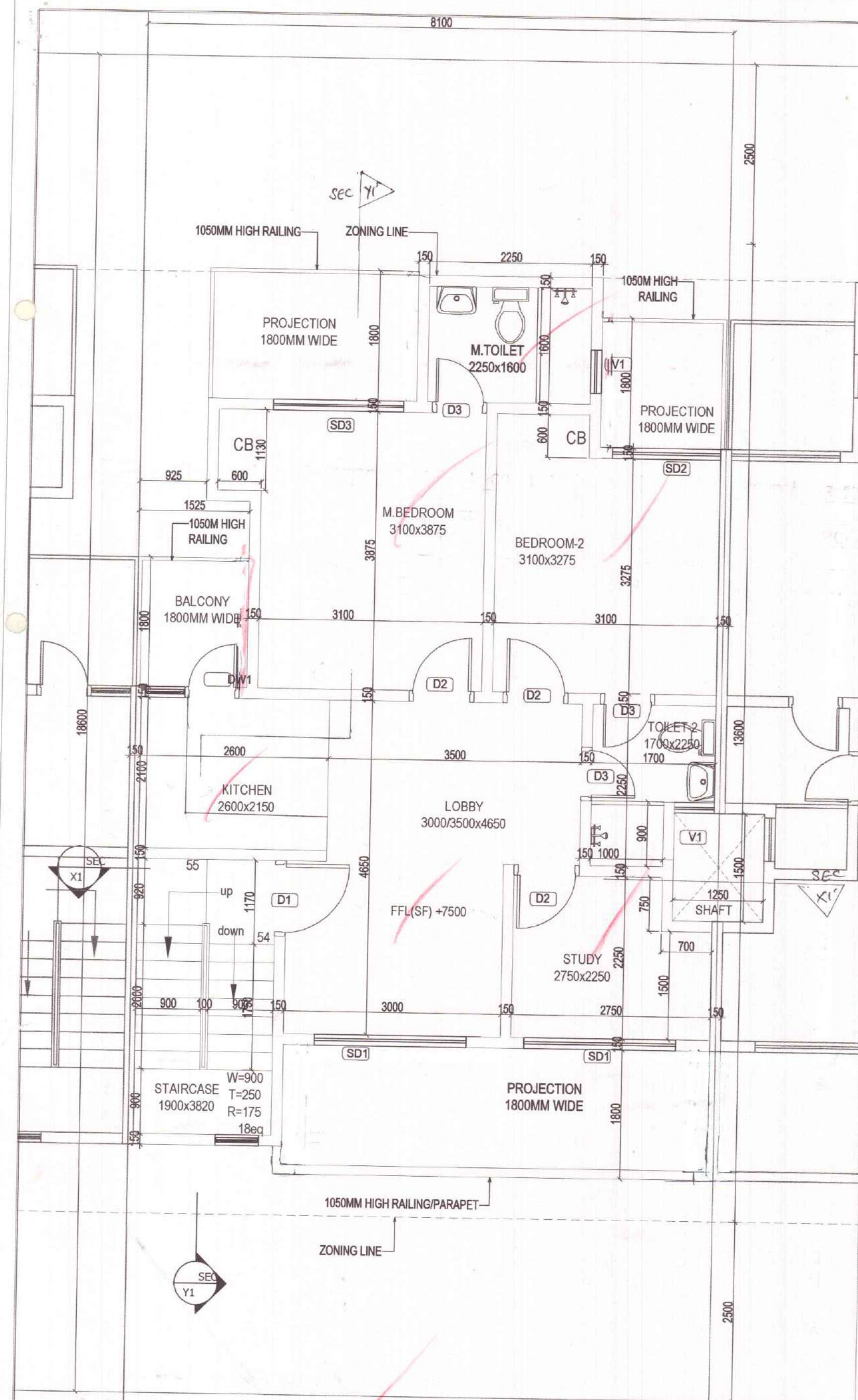

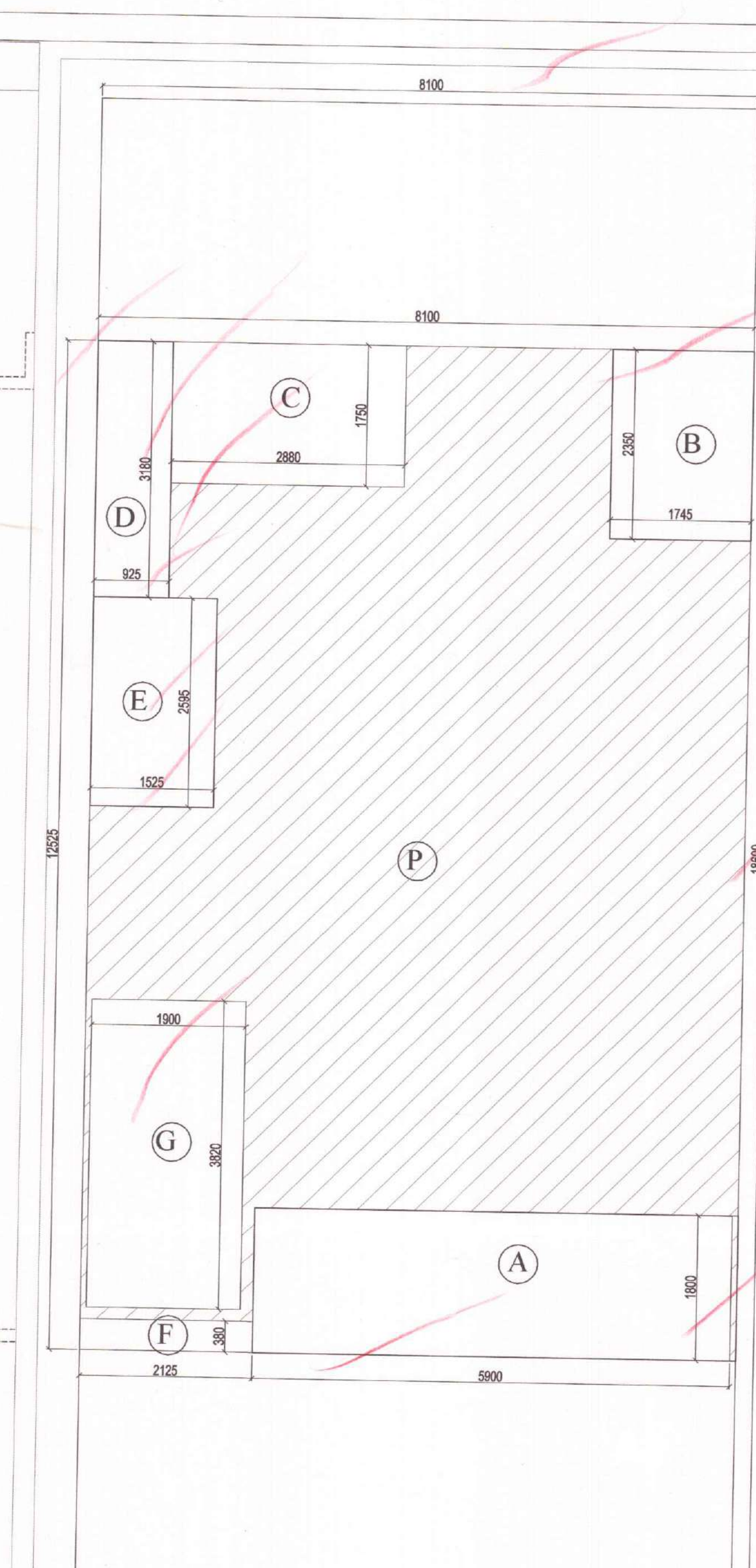




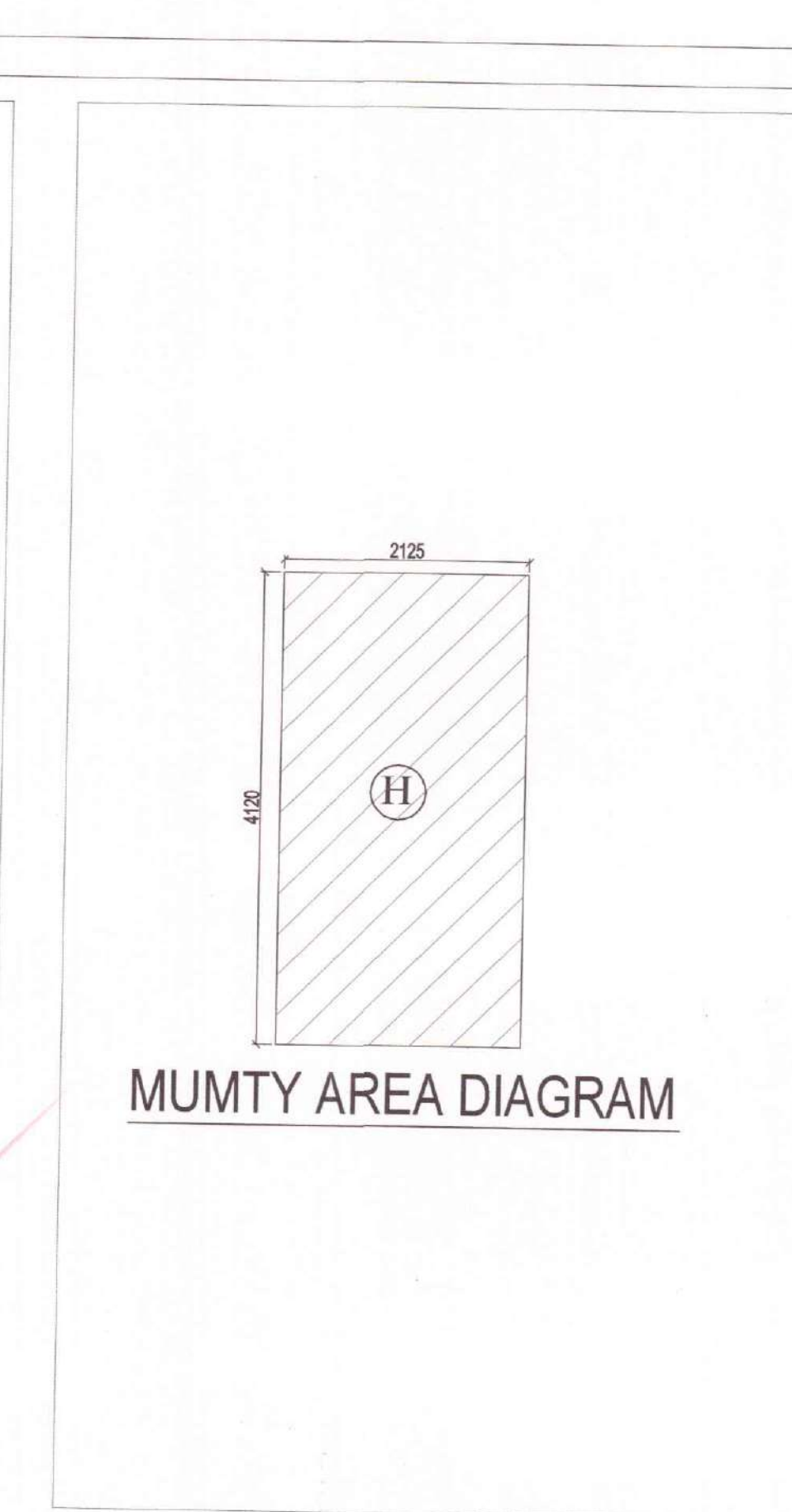
SECOND FLOOR PLAN

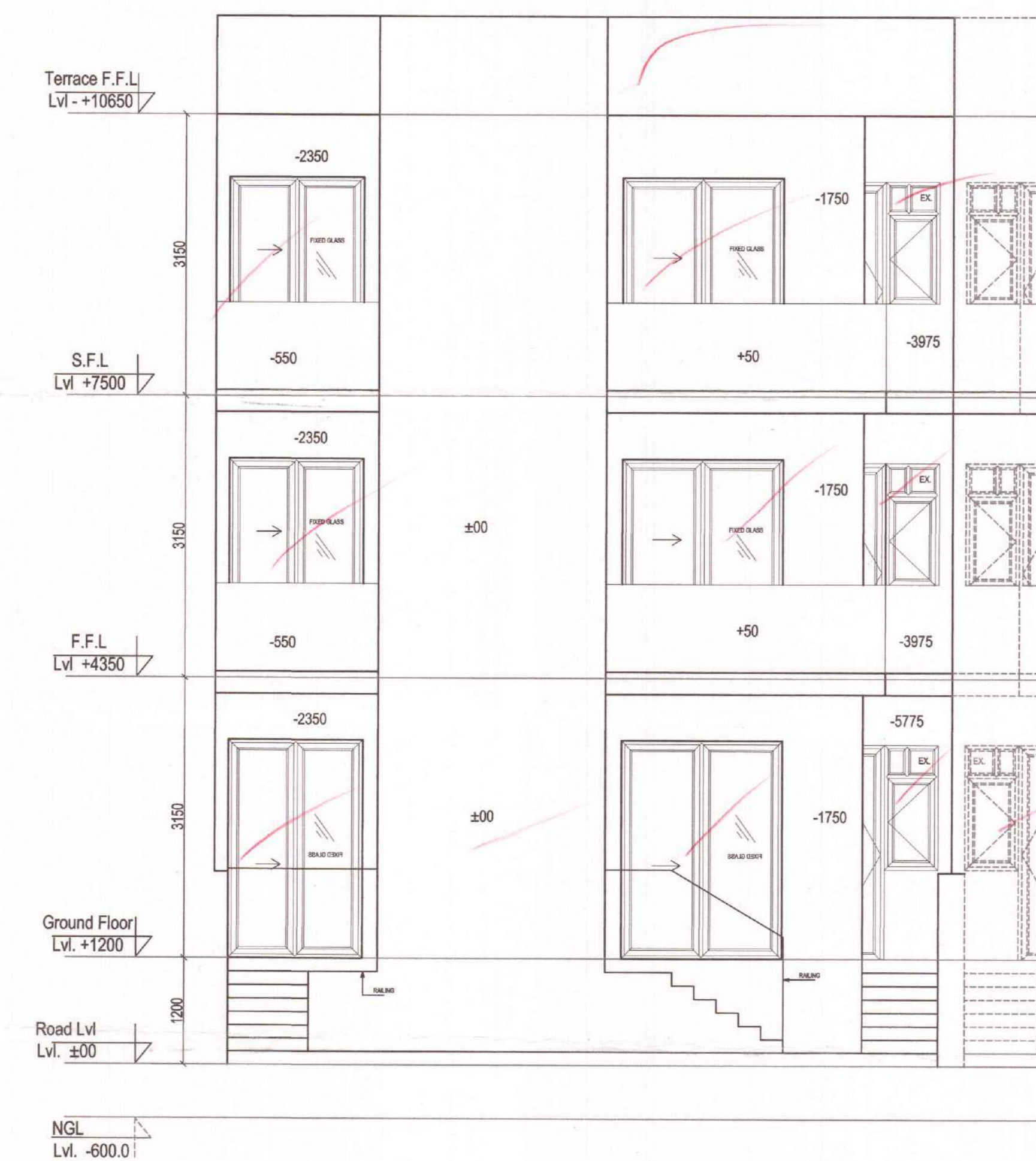




Section X1-X1'

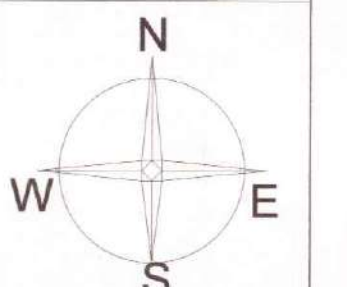
