ORDER

In pursuance to this office Endst. No. LC-4749/JE(SB)/2022/35435-448 25.11.2022, Licence no. 193 of 2022 dated 24.11.2022 was granted to Godson Propbuild Pvt. Ltd. in collaboration with MGF Development Ltd. for setting up of Affordable Plotted Colony under DDJAY on the land measuring 5.0125 acres in the revenue estate of village Sikanderpur Badha, Sector-85, Gurugram under the provisions of Haryana Development and Regulation of Urban Areas Act, 1975 and the Rules framed thereunder. As per terms and conditions of the licence and the agreement executed on LC-IV, the colonizer was required to comply with the provisions of the Act 1975 and the Rules 1976 thereof.

And whereas the request dated 27.12.2022 was received from MGF Development Ltd. for transfer of licence and change of developer in favour of Hero Realty Pvt. Ltd. under the provisions of Rule 17 of Rules 1976 and Policy Dated 18.02.2015. The in-principle approval regarding the same was granted on 23.01.2023 and submitted compliance accordingly. The request for change of developer and transfer of entire licenced land has been considered subject to the condition that the developer company i.e. Hero Realty Pvt. Ltd. shall be responsible for compliance of all the terms and conditions of the licence and provisions of Act/Rules and abide by all the terms and conditions of the agreement executed till the grant of final completion certificate to the colony or relieved of the responsibility whichever is earlier and shall settle all the pending/outstanding issues, if any, in respect of all the existing as well as prospective allottees.

The approval of all the plans accorded in favour of original licensees shall now be deemed approved in favour of Hero Realty Pvt. Ltd. The revised land scheduled is enclosed.

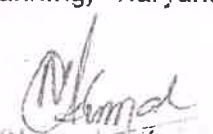
