Affidavit cum Declaration of Mr. Kanwal Preet Singh Babber authorised signatory of the promoter i.e TRIDENT HILLS PRIVATE LTD (formerly known as IREO FIVERIVER PVT. LTD.) of the proposed project over an area 6.31837 Acres namely "Windsong Residences 2", falling in village Islamnagar, sector-3,4 & 4A, Distt. Panchkula, Haryana;

I, Kanwal Preet Singh Babber duly authorized by the promoter of the proposed project do, hereby solemnly declare, undertake and state as under:

1. That the Promoter along with its group companies has a legal title to the land on which the development of the project is proposed

and

a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.
- 5. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 6. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered account and produce a statement of (Formerly Known as Considering Private Limited)

accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- 7. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
