This license has been granted under the Haryana Development and Regulation of Urban Areas Act 1975 & the Rules 1976 made thereunder to DLF Home Developers Ltd., First Floor, DLF Gateway Tower, R- Block, DLF City Phase-3, Gurgaon - 122002 for setting up of Residential Plotted Colony under NILP Policy over an area measuring 10.77 acres (migration from Licence no. 218 of 2007, 276 of 2007 & 139 of 2008) in the revenue estate of village Shimla Molana, Sector-40, Panipat.

- 1. The particulars of the land, wherein the aforesaid Residential Plotted Colony under NILP Policy is to be set up, are given in the Schedule annexed hereto and duly signed by the Director General, Town & Country Planning, Haryana.
- 2. The Licence is granted subject to the following conditions:
  - a. That the Residential Plotted Colony under NILP Policy will be laid out in confirmation to the approved layout plan and development works will be executed in accordance to the designs and specifications shown in the approved plans.
  - b. That the conditions of the agreements already executed are duly fulfilled and the provisions of Haryana Development and Regulation of Urban Areas Act, 1975 and the Rules 1976 made thereunder are duly complied with.
  - c. That the licensee shall maintain and upkeep of all roads, open spaces, public park and public health services for a period of five years from the date of issue of the completion certificate unless earlier relieved of this responsibility and thereupon to transfer all such roads, open spaces, public parks and public health services to the Govt. or the local authority, as the case may be, in accordance with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.
  - d. That area coming under the sector roads, restricted belt/green belt and community sites if any, which forms part of licensed area and in lieu of which benefit to the extent permissible as per policy towards FAR is being granted, shall be transferred to the Govt. within 30 days of approval of zoning plan.
  - e. That you shall construct portion of service road, internal circulation roads, forming the part of site area at your own cost and shall transfer the land falling within alignment of same to the Govt. u/s 3(3) (a) (iii) of the Haryana Development and Regulation of Urban Areas Act, 1975 within 30 days of approval of zoning plan.

That you shall integrate the services with Haryana Shehri Vikas Pradhikaran services as and when made available.

The you have not submitted any other application for grant of license for development of the said land or part thereof for any purpose under the provisions of the Haryana Development and Regulation of Urban Areas Act, 1975 or any application seeking permission for change of land use under the

provision of the Punjab Scheduled Roads and Controlled Area Restrictions of Unregulated Development Act, 1963.

- h. That you shall understand that the development/construction cost of 24 m/18 m major internal roads is not included in the EDC rates and they shall pay the proportionate cost for acquisition of land, if any, alongwith the construction cost of 24 m/18 m wide major internal roads as and when finalized and demanded by the Department.
- i. That you shall obtain NOC/Clearance as per provisions of notification dated 14.09.2006 issued by Ministry of Environment & Forest, Govt. of India, if applicable before execution of development works at site.
- That you shall make your own arrangements for water supply, sewerage, j. drainage etc. to the satisfaction of DGTCP till these services are made available and the same is made functional from External Infrastructure to be laid by Haryana Shahari Vikas Pradhikaran services or any other execution agency.
- That you shall obtain clearance from competent authority, if required k. under Punjab Land Preservation Land Act, 1900 and any other clearance required under any other law.
- That the rain water harvesting system shall be provided as per Central l. Ground Water Authority Norms/Haryana Govt. notification as applicable.
- That you shall use only LED fitting for internal lighting as well as campus m. lighting.
- That you shall convey the 'Ultimate Power Load Requirement' of the n. project to the concerned power utility, with a copy to the Director, within two months period from the date of grant of license to enable provision of site in licensed land for Transformers/Switching Stations/Electric Sub Stations as per the norms prescribed by the power utility in the zoning plan of the project.
- That it will be made clear at the time of booking of plots/commercial o. space that specified rates include or do not include EDC/SIDC. In case of not inclusion of EDC/SIDC in the booking rates, then it may be specified that same are to be charged separately as per rate fixed by the Govt. You shall also provide detail of calculation of EDC/SIDC per sqm/per sqft to the allottees while raising such demand from the plot owners.
- That you shall keep pace of development at least in accordance with sale p. agreement executed with the buyers of the plots as and when scheme is launched.
- That you shall arrange power connection from UHBVNL/DHBVNL for a. electrification of the colony and shall install the electricity distribution infrastructure as per the peak load requirement of the colony for which licencee shall get the electrical (distribution) service plan/estimates approved from the agency responsible for installation of external electric services i.e. UHBVNL/DHBVNL and complete the same before obtaining completion certificate for the colony.
- r. That you will pay the labour cess as per policy instructions issued by Haryana Government vide memo no. Misc-2057-5/25/2008/2TCP dated 25.02.2010 and as amended time to time.

That you shall submit compliance of Rule 24, 26, 27 & 28 of Rules 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, and shall inform account number and full particulars of the scheduled bank wherein licencee have to deposit the amount received from the plot holders for meeting the cost of Internal Development Works in the colony.

- t. That no further sale has taken place after submitting application for grant of license.
- u. That you shall not give any advertisement for sale of plots/ commercial are before the approval of layout plan.
- v. That you shall follow the provisions of the Real Estate (Regulations and Development) Act, 2016 and Rules framed thereunder shall be followed by the you in letter and spirit.
- w. That no provision of the Haryana Ceiling on Land Holding Act, 1972 has been violated due to purchase of applied land.
- x. That you shall abide with policies dated 18.02.2016 and 11.05.2022 as amended from time to time.
- y. That you shall integrate the bank account in which 70 percent allottee receipts are credited under Section-4(2)(I)(D) of the Real Estate Regulation and Development Act, 2016 with the online application/payment gateway of the Department, in such manner, so as to ensure that 10% of the total receipt from each payment made by an allottee is automatically deducted and gets credited to the EDC head in the State treasury.
- z. That such 10% of the total receipt from each payment made by the allottee, which is received by the Department shall get automatically credited, on the date of receipt in the Government treasury against EDC dues.
- aa. That such 10% deduction shall continue to operate till the total EDC dues get recovered from the owner/developer.
- bb. The implementation of such mechanism shall, however, have no bearing on EDC installment schedule conveyed to the owner/developer. The owner/developer shall continue to supplement such automatic EDC deductions with payments from its own funds to ensure that by the EDC installments that are due for payment that paid as per the prescribed schedule.
- Cc. That you shall execute the development works as per Environmental Clearance and comply with the provisions of Environment Protection Act, 1986, Air (Prevention and Control of Pollution of Act 1981) and Water (Prevention and Control of Pollution of 1974). In case of any violation of the provisions of said statutes, you shall be liable for penal action by Haryana State Pollution Controlled Board or any other Authority Administering the said Act.
- dd. That you/colonizer shall abide by all the provisions of Act no. 8 of 1975 and Rules framed thereunder as amended time to time.
- ee. That you shall complete the project within seven years (5+2 years) from date of grant of license as per clause 9.2 of the policy dated 11.05.2022.

- ff. That you shall submit undertaking regarding transfer of land falling under sector roads, green belts, service roads, internal sector plan roads, community sites within 30 days of approval of zoning plan, within a period of 30 days of issuance of licence.
- 3. That you shall submit access permission from NHAI before approval of Service Plan estimates.
