- 6. That you shall start the development work at site after getting approval/NOC from the competent authority in pursuance of MoEF notification dated 14.09.2006.
- 7. That you shall convey ultimate power load requirement of the project from the competent authority within 60 days of HRERA registration.
- 8. That you shall get the licence renewed till final completion of the colony is granted.

The renewal of licence will be void ab-initio, if any of the above conditions is not complied with.

## **ORDER**

Whereas, license No. 101 of 2011 dated 29.11.2011 was granted in favour of Celestial Estates Pvt. Ltd. for setting up of a Commercial Colony over an area measuring 3.409 acres in the revenue estate of Village Fazilpur Jharsa, Sector-71, Gurugram. The licence was valid upto 28.11.2015.

As per terms and conditions of licence, the licensee was required to comply with the provisions of Haryana Development and Regulation of Urban Areas Act, 1975 and Rules framed thereunder and the terms and conditions of the agreement/ bilateral agreement executed by the licencee with Director, Town and Country Planning on 29.11.2011. It was noticed that the license was granted in favour of Celestial Estates Pvt. Ltd., however, the compliance was being done by Earth Infrastructure Ltd. Therefore, the license was cancelled vide order dated 04.01.2017 as the applicant company had failed to rectify the deficiencies conveyed vide memo dated 16.11.2015. The company went under Insolvency Proceedings and Hon'ble NCLT passed orders dated 15.03.2021 stating that all the statutory duties including taxes/cess/interest/penalty and other liabilities due to the operational creditors shall stand satisfied/waived off. However, after obtaining legal opinion from Ld. AG, Haryana, vide letter dated 23.09.2022, the applicant company was directed to deposit the outstanding dues alongwith interest and filed an affidavit in IA no. 2248 of 2022 in CP(PB) no. 1768 (ND)/2018 in the matter of Sanjay Malik and others Vs Celestial Estates Pvt. Ltd. and H.S. Oberoi Buildtech Pvt. Ltd. Vs DGTCP.

The company namely H.S. Oberoi Buildtech Pvt. Ltd. as successful resolution applicant has taken over the developer company Celestial Estates Pvt. Ltd. submitted the representation that in the interest of 400 allottees, they are willing to clear the outstanding dues. The applicant company has cleared the outstanding dues and deposited outstanding renewal fee by availing the Government Schemes "Samadhan Se Vikas" and "Vivado ka Samadhan". Further, vide letter dated 09.06.2023 company has been directed to open an ESCROW account where the Department will have first charge on the amount received in the said accounts and company shall pay requisite charges pertaining to change in beneficial interest as per policy dated 18.02.2015, within two months of RERA approval/registration.

Accordingly, in view of the orders of Hon'ble NCLT and to safeguard interest of 400 allottees and keeping in view that all the outstanding dues/ Govt. fee and charges are paid and company has also undertaken to open an ESCROW account, the request of applicant company to restore the license is hereby considered.
