1. That Bestech India Pvt. Ltd. a Company incorporated under the Companies Act, 1956 and existing under the Companies Act, 2013 (CIN no.- U99999DL2001PTC110996) having its corporate office at Bestech House, Plot No.-51, Institutional Area, Sector-44, Gurugram-122002, Haryana and registered office at office No. 5D, 5th Floor, Aria Signature Offices, JW Marriot Hotel Delhi Aero City, Hospitality District, Near IGI Airport, New Delhi along with other land owners by virtue of Collaboration Agreement has a legal title to the land on which the development of the project is proposed.
2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by M/s Bestech India Pvt. Ltd.

is 16.09.2026.

4. That seventy per cent of the amounts realised by Company (M/s Bestech India Pvt. Ltd) for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by Company (M/s Bestech India Pvt. Ltd) in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn Company (M/s Bestech India Pvt. Ltd) after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That Company (M/s Bestech India Pvt. Ltd) shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That Company (M/s Bestech India Pvt. Ltd) shall take all the pending approvals on time, from the competent authorities.
9. That Company (M/s Bestech India Pvt. Ltd) has] furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That Company (M/s Bestech India Pvt. Ltd) shall not discriminate against any allottees at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
