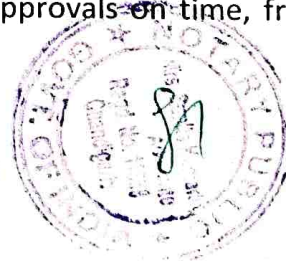


I, Raj Mathura authorized Signatory the Promoter Company of the proposed project do hereby solemnly declare, undertake and state under:
