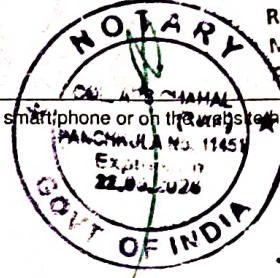

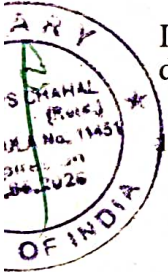
Affidavit cum Declaration

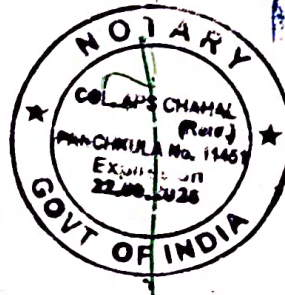

8. That the promoter shall take all the pending approvals on time, from the competent authorities.
