Affidavit cum Declaration

Affidavit cum Declaration of Mr. Kapil Chhabra, duly authorized by the promoter of the proposed project, vide its authorization dated 07.12.2023.

- I, Kapil Chhabra, duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:
- 1. That M/s Shri Ram Sharanam Consultants Private Limited has a legal title to the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by promoter is 31.01.2028.
- 4. That seventy per cent of the amounts realised by M/s Shri Ram Sharanam Consultants Pvt. Ltd. for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
