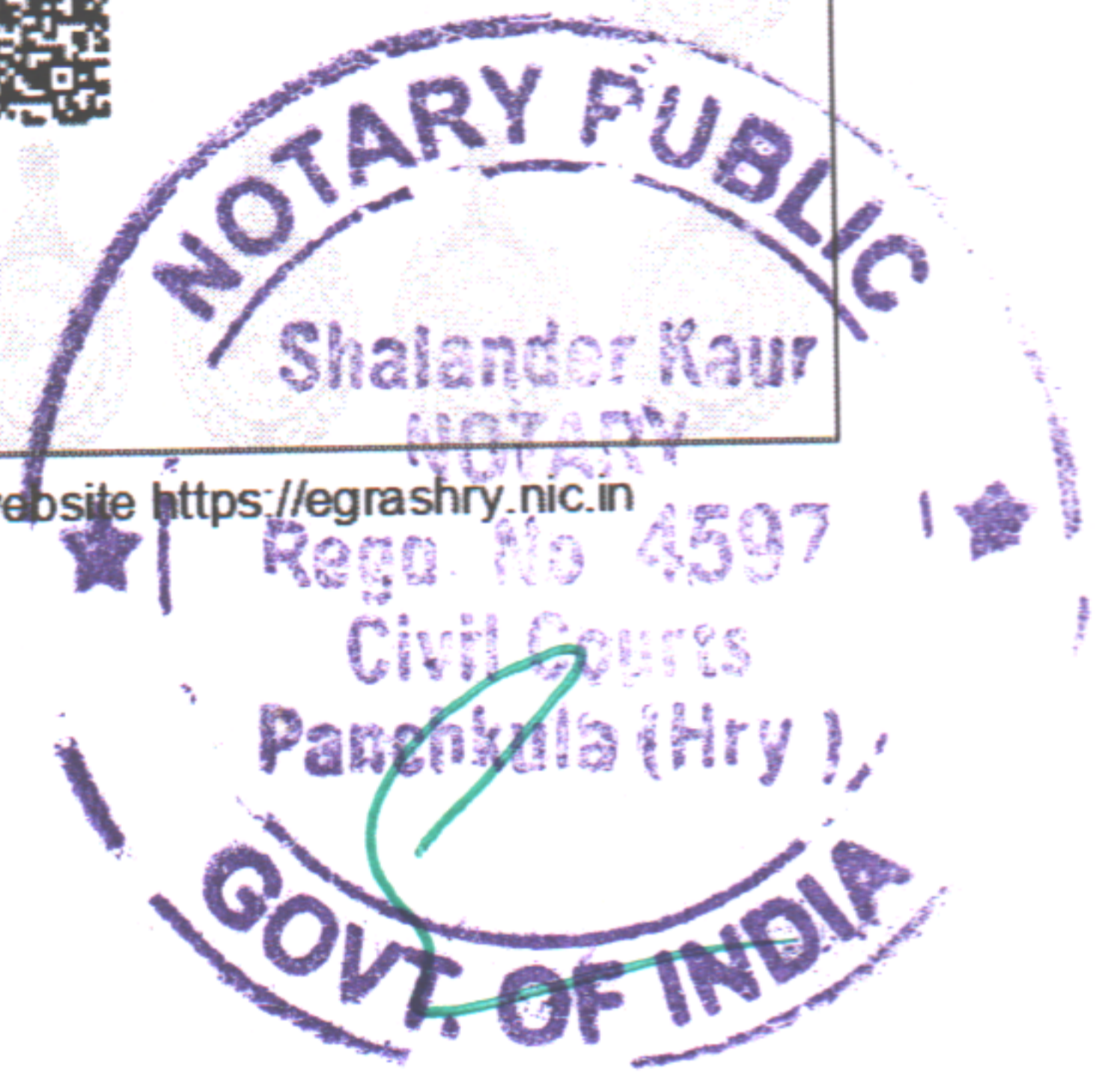

We, Mandeep Sheokand & Guljinder Singh duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

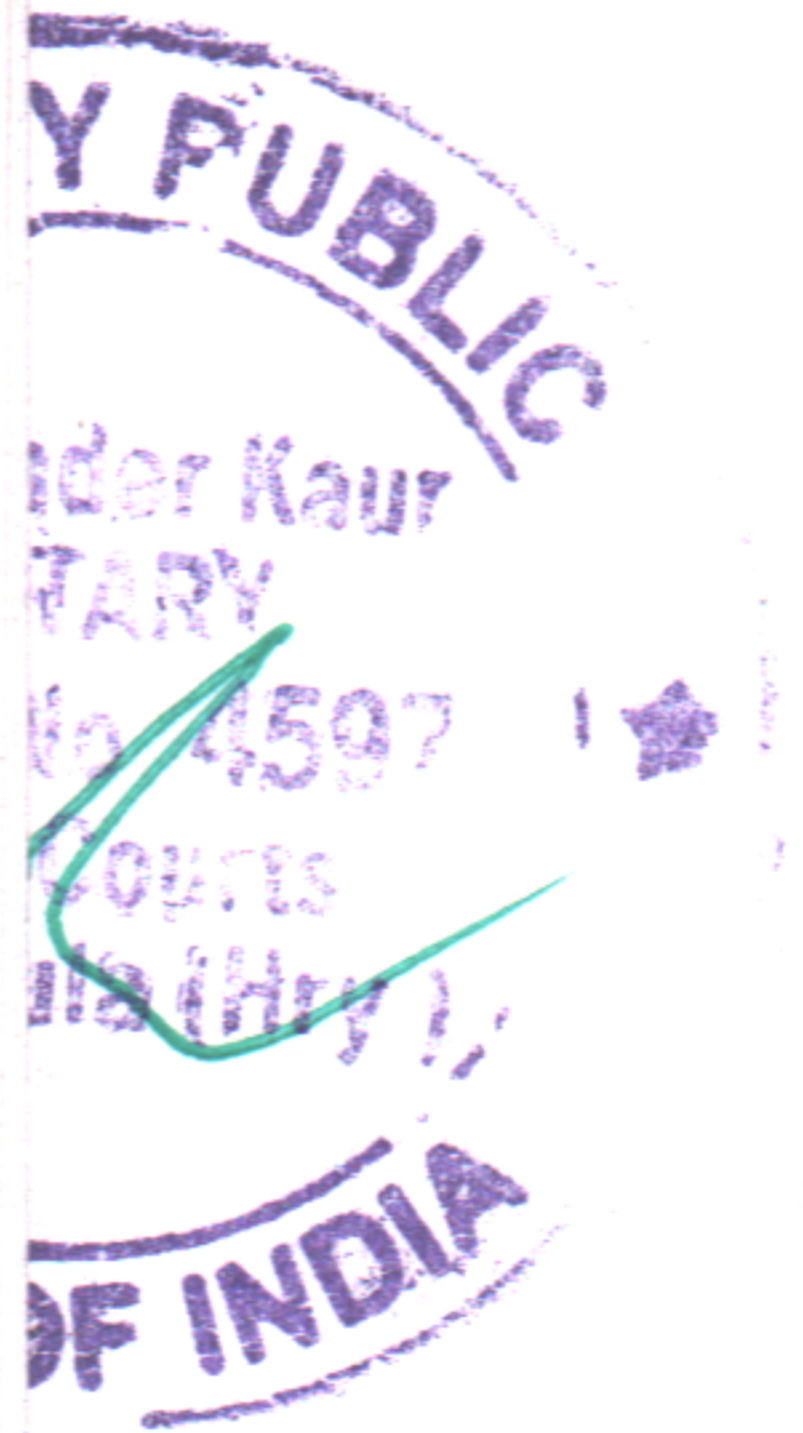
1. That M/s Sigma Reality has a legal title to the land on which the development of the project is proposed.





7.
