5. Fire safety measures as per NBC includes smoke detector, heat, door, sprinkler spacing in compliance with code.
6. All external walls are 200mm and all internal walls are 100mm thick. (Valid for all drawings)

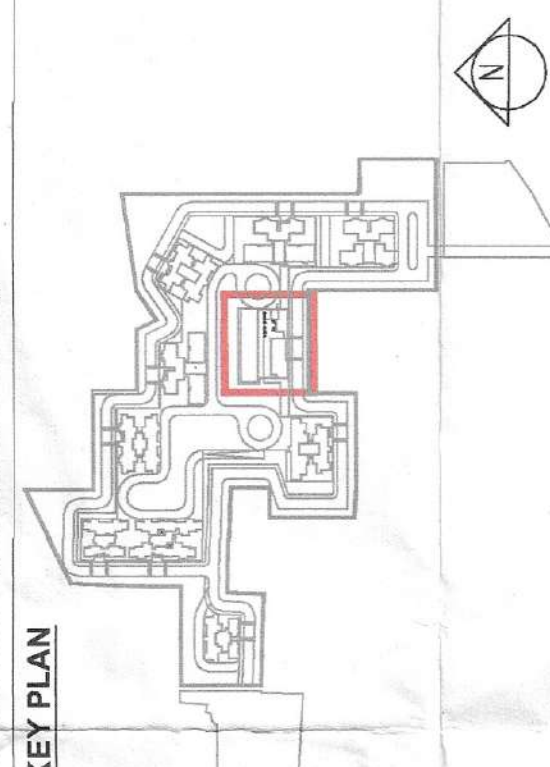
