No. 90 Killa No. 1/1/1, 1/1/2, 1/2/1, 1/2/2, 8, 9/1, 9/2, 10, 11, 12, 13, 20. Rect. No. 91 Killa No. 4, 5/1, 5/2, 6/1, 6/2, 7, 15, 16, 17/1, 21/2, 22, 23, 24, 25. Rect. No. 92 Killa No. 3, 4. Land located at village Wazirpur and land measuring 20.543 Acres having Rect. No. 1 Killa No. 23, 24, 25. Rect. No. 2 Killa No. 14, 17, 18, 21, 22, 23, 24. Rect.
