You are hereby authorized to connect 500mm dia main sewer line for dispose off surplus treated sewage water only after functional of Master Sewer line in the area including functioning of STP. In addition to the above you are requested to furnish and affidavit that you will have to deposit the monthly sewerage charges on the rates fixed by competent authority from time to time. The sewerage connection is sanctioned with reference to your undertaking/affidavit and subject to the following terms and conditions:-

1. The connection will be made only after functional of Master Sewer line in the area including functioning of STP. The expenses on making connection will be borne by you complete in all respect. Till the completion of sewerage network, you are fully responsible to dispose off the surplus treated water at adequate place with prior permission from concerned office.
2. An amount of Rs.300000/- has been received in GMDA account on dated 09.06.2022 vide ref no. GMDA SRWC 342291654667993806 file id SRWC-1646304705813 and transaction id 111528894756 on account of security charges and sewer connection fee in GMDA, Gurugram
3. If any services or road crossing required at site, the permission may be obtain from the concerned Executive Engineer of GMDA Gurugram.
4. M/s Super Belts Pvt. Ltd. & Others C/o Countrywide Promoters Private Limited will deposit the EDC (External Development Charges) as fixed by competent authority.
5. Sewer connection shall be released in the presence of the representative of M/s Super Belts Pvt. Ltd. & Others C/o Countrywide Promoters Private Limited and the monthly charges shall also be paid by the firm regularly.
6. The connection shall be maintained strictly as per rules and regulations framed by GMDA.
7. Sewer connection will be utilized for dispose off the sewage water as approved in drawings of above site i.e. Group Housing Colony "Park Serene" an area measuring 176272.972 sqm, License No. 83 of 2008 & 94 of 2011 falling in Sector No. 37D, Gurugram being developed by M/s Super Belts Pvt. Ltd. & Others C/o Countrywide Promoters Private Limited.
8. For any dispute in connection with the release of sewer connection/ maintenance and

disconnection, etc. for the said sewer connection and matter shall be referred by any of the two parties to the concerned Superintending Engineer, GMDA, Gurugram and his decision in the matter shall be final and legally binding on both the parties.

9. Checking of actual assessment of discharge and verification shall be made jointly by the representative of Dept. and colonizer based on discharge of pipes / area.
10. You will not be allowed to dispose sewage water in any other natural drain & FIR may be lodged in case of non-compliances. The case of violation the sewer connection will be summarily cancelled.
11. You may also ensure that follow the guide lines of N.G.T/HSPCB/CPCB regarding the STP as per Honble Supreme Court.
12. The treated sewage from your factory will be discharged into GMDA Master Sewer line and all norms for disposal of waste water shall be fulfilled as fixed by HSPCB/CPCB/NGT Or Any other controlling authority in Gurugram.
