



### **Affidavit cum Declaration**

Affidavit cum Declaration of Mr. Vipin Jain, duly authorized by the promoter of the proposed project, vide its authorization dated  $13^{th}$  June 2017

- 1. That M/s Krrish Realtech Pvt. Ltd. [Promoter] has adequate legal rights and entitlements to develop the proposed project by virtue of a legally valid settlement agreement dated 06.08.2012 and dated 31.12.2015 determining the rights of Brhama City Pvt. - 2. That the said land is free from all encumbrances.

- 6. That the amounts from the separate account shall be withdrawn [me/ the promoter] after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That the promoter has furnished such other documents as have been Prescribed by the Act and the rules and regulations made there under.
