Your site is located at a distance 13311 mts from ARP and lies in the grid R9 of the published CCZM of I.G.I Airport airport. The Permitted top elevation for this grid is 330 mts.

Since the requested top elevation 329 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.
