Sub.: Clarification regarding Applicability of forest laws on Non Forest land Applied by M/s Jubiliant Malls Pvt. Ltd. & Other's located at Village Basai, Sector-37C, District-Gurgaon.

Applicant by M/s Jubiliant Malls Pvt. Ltd. & Other's, G-100, Road No-13A, Kalindi Kunj, Jasola, New Delhi-110025 vide letter no. Nil dated 23-10-2012 made a request in connection with land measuring 22.3453 Acres having Khasra No. 468/1, 468/2, 469/2, 741, 742/1/1, 742/1/2, 742/2, 743, 745/1, 745/2, 746min, 746min, 751, 752/4 located at village Basai District Gurgaon. Applicant made a proposal to use this land for Group Housing Project. In continuation of reports submitted by RFO, Gurgaon vide Letter No. 849-G dated 26.11.2012 and approval from C.F. South Circle, Gurgaon vide letter No.4276 dated 11.01.2013, it is made clear that:

- a) As per record available above said land is not part of notified / closed area under IFA 1927/FCA1980/Specific section 4 & 5 of PLPA 1900/ WLPA1972/ or any other forest land.
- b) It is clarified that by the Notification No. S.O.8/P.A 2/1900/S.4/2013 dated 4th January, 2013, all Revenue Estate of Gurgaon Tehsil is notified u/s 4 of PLPA 1900 and S.O.113/PA.2/1900/S.3/97 dated 17th November, 1997 u/s 3 of PLPA 1900. The area is however not recorded as forest in the Government record but felling of any tree is strictly prohibited without the permission of Divisional Forest Officer, Gurgaon.
- c) If approach is required from Protected Forests by the user agency, the clearance/regularization under Forest Conservation Act 1980 will be required. Without prior clearance from Forest Department, the use of Forest land for approach road is strictly prohibited M/s Jubiliant Malls Pvt. Ltd. & Other's land located at village Basai, Sector-37C, District Gurgaon must obtain clearance and approach the Divisional Forest Officer, Gurgaon for the permission under Forest Conservation Act 1980.
- d) As per record with the Forest Department, Gurgaon, the area does not fall under Aravalli Project Plantation done by the Forest Department.
- e) All other statutory clearance mandated under the Environment Protection Act. 1986 or any other Act/order shall be obtained as applicable by the project proponents from the concerned authorities.
- f) The project proponent will not violate any Judicial Order/ Pronouncement issued by the Hon'ble Supreme Court/ High Courts.
- g) It is clarified that the Hon'ble Supreme Court has issued various judgment dated 07.05.2002, 29.10.2002, 16.12.2002, 18.03.2004 etc. pertaining to Aravalli region in Haryana, should be followed.
