Your request for the grant of license under section 3 of the Haryana Development and Regulation of Urban Areas Act, 1975 and the Haryana Development and Regulation of Urban Areas Rules, 1976 framed thereunder for the development of an Affordable Plotted Colony (DDJAY-2016) for an additional area measuring 7.7222 acres in addition to licence no. 78 of 2022 dated 24.06.2022 in revenue estate of Village Gopalpur, Tehsil Harsaru, Sector-99A, District Gurugram has been examined/considered by the Department under the policy dated 08.02.2016 and it is proposed to grant license to you. Further, following additional clauses shall be added in LC-IV agreement as per Government instruction dated 14.08.2020.
 - i. That the owner/developer shall integrate the bank account in which 70 percent allottee receipts are credited under Section-4(2)(I)(D) of the Real Estate Regulation and Development Act, 2016 with the online application/payment gateway of the Department, in such manner, so as to ensure that 10% of the total receipt from each payment made by an allottee is automatically deducted and gets credited to the EDC head in the State treasury.
