Affidavit cum Declaration of Mr. Rajeev Trehan S/o Late Sh. Rajindar Kumar aged about 65 years, R/o B-2-1, Greater Kailash-1, South Delhi, Delhi-110048, duly authorized by the promoter TARC Limited vide a resolution of the Board dated November 12, 2022, for the company's Group Housing Project "TARC Ishva", on the land parcel admeasuring 6.95 Acres situated in the revenue estate of Village Maidawas, Sector 63A, Gurgaon, Haryana.

I, Rajeev Trehan duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake, and state as under:

- That The Promoter TARC Limited having its registered office at C-3, Qutab Institutional Area, Katwaria Sarai, New Delhi – 110016 has a legal title to the land on which the development of the project is proposed Total licensed Area is 6.95 Acres (License No. 137 of 2023 dated 05/07/2023).


