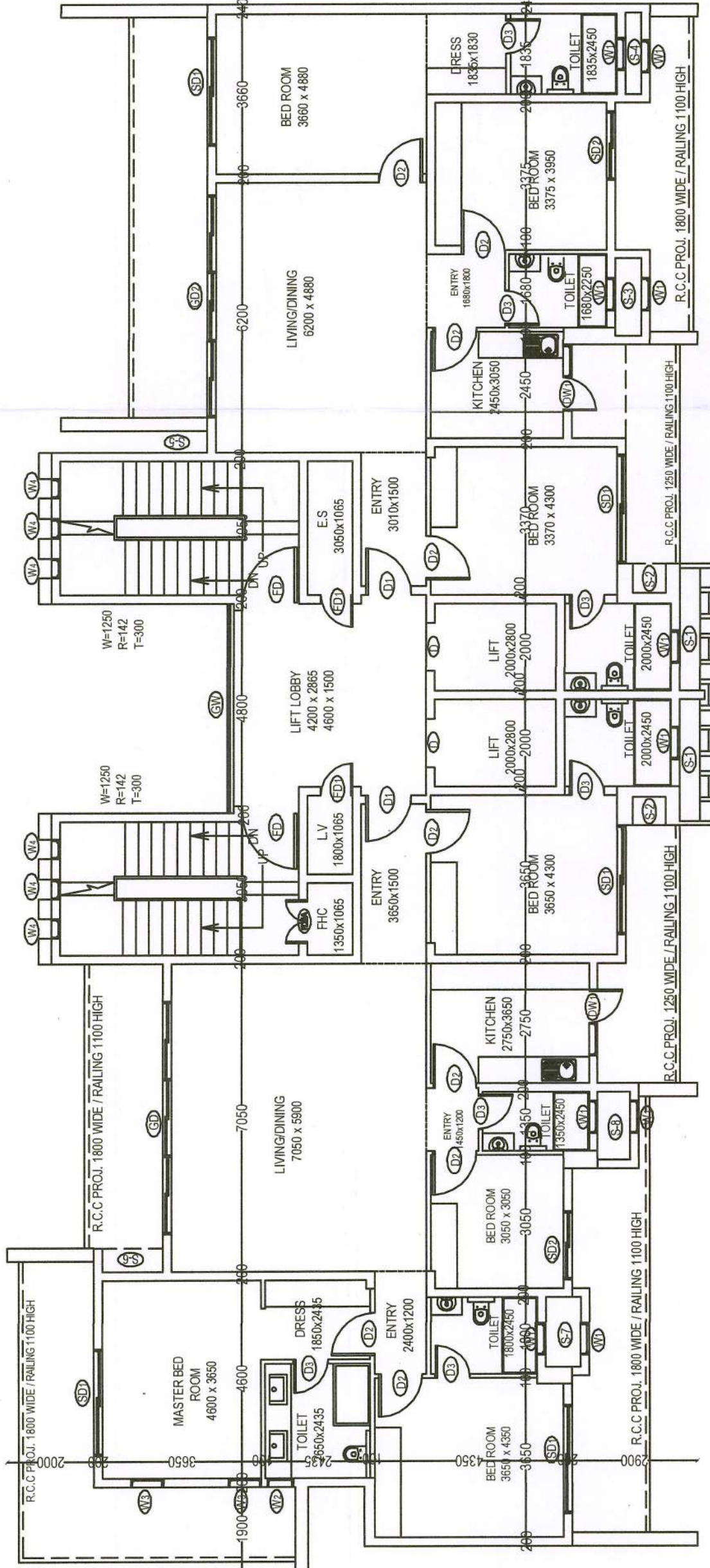
TWENTY THREE FLOOR PLAN.



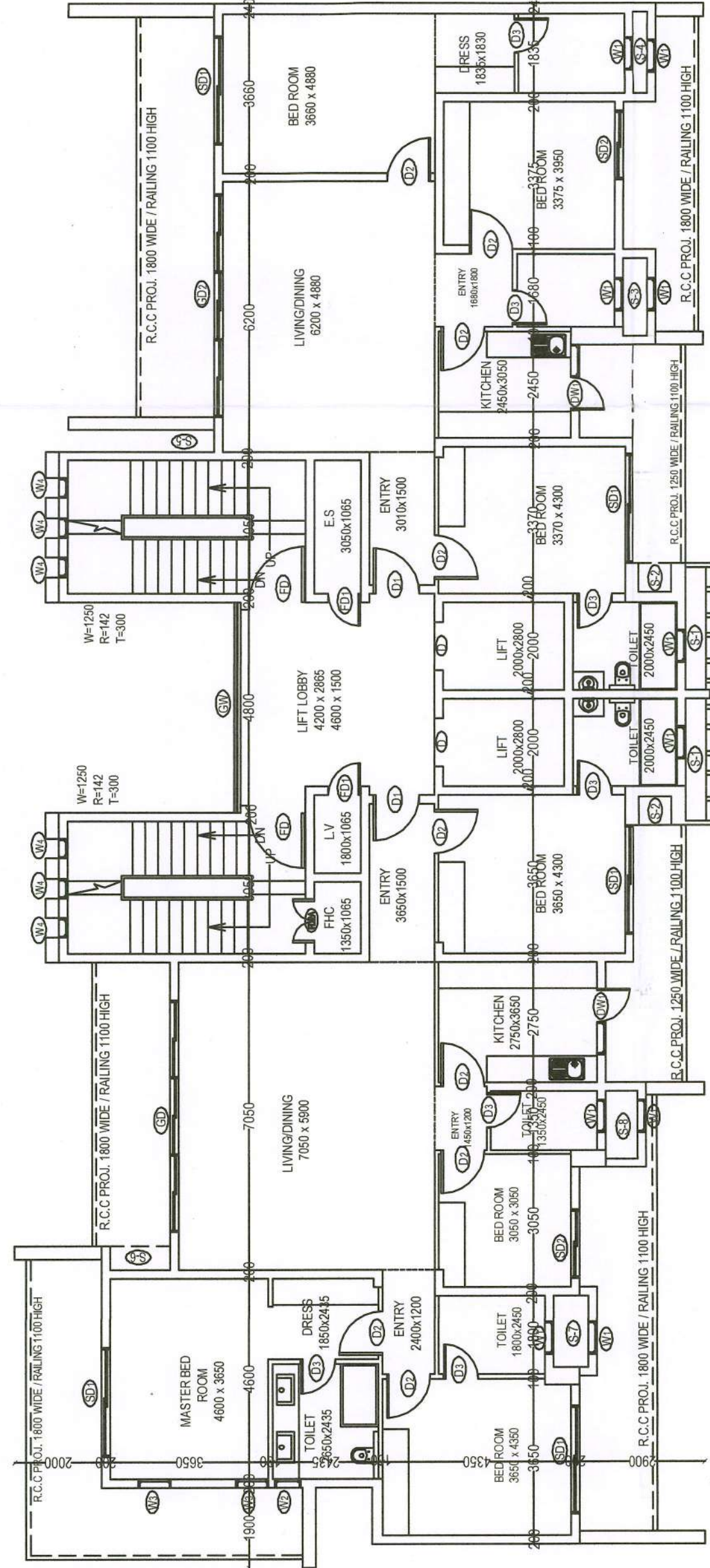
TWENTYTHREE COORDINATE



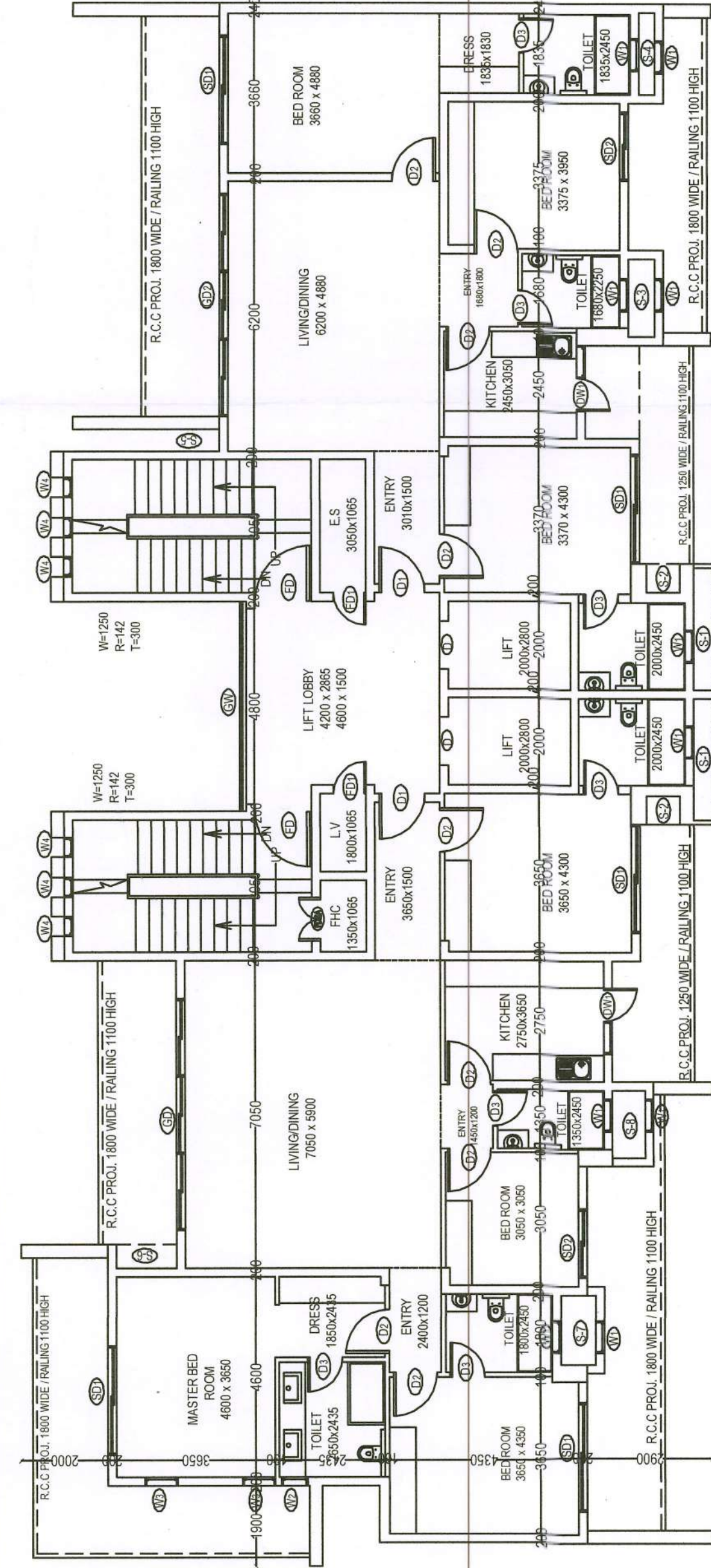
FOURTEENTH FLOOR PLAN



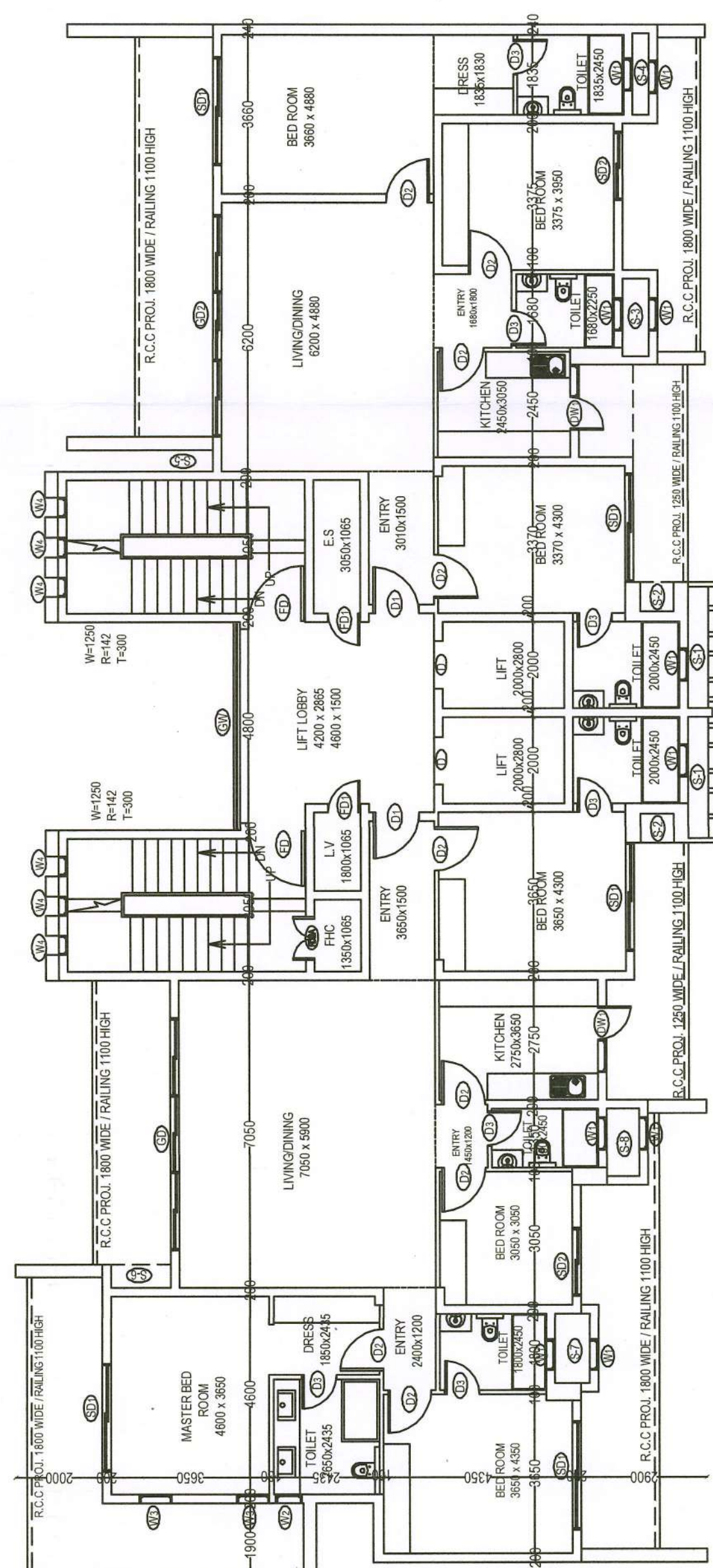
TWEENTY TWO FLOOR PLAN



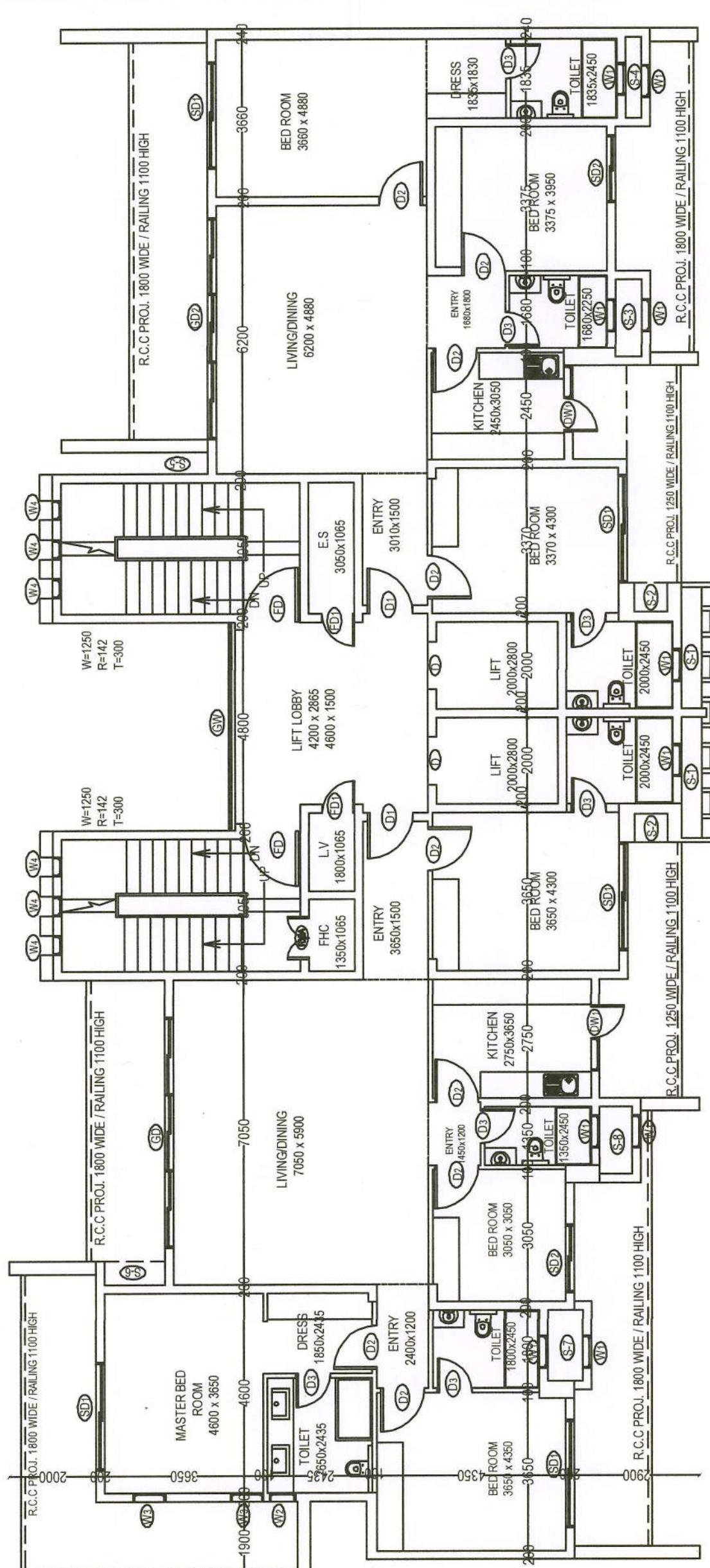

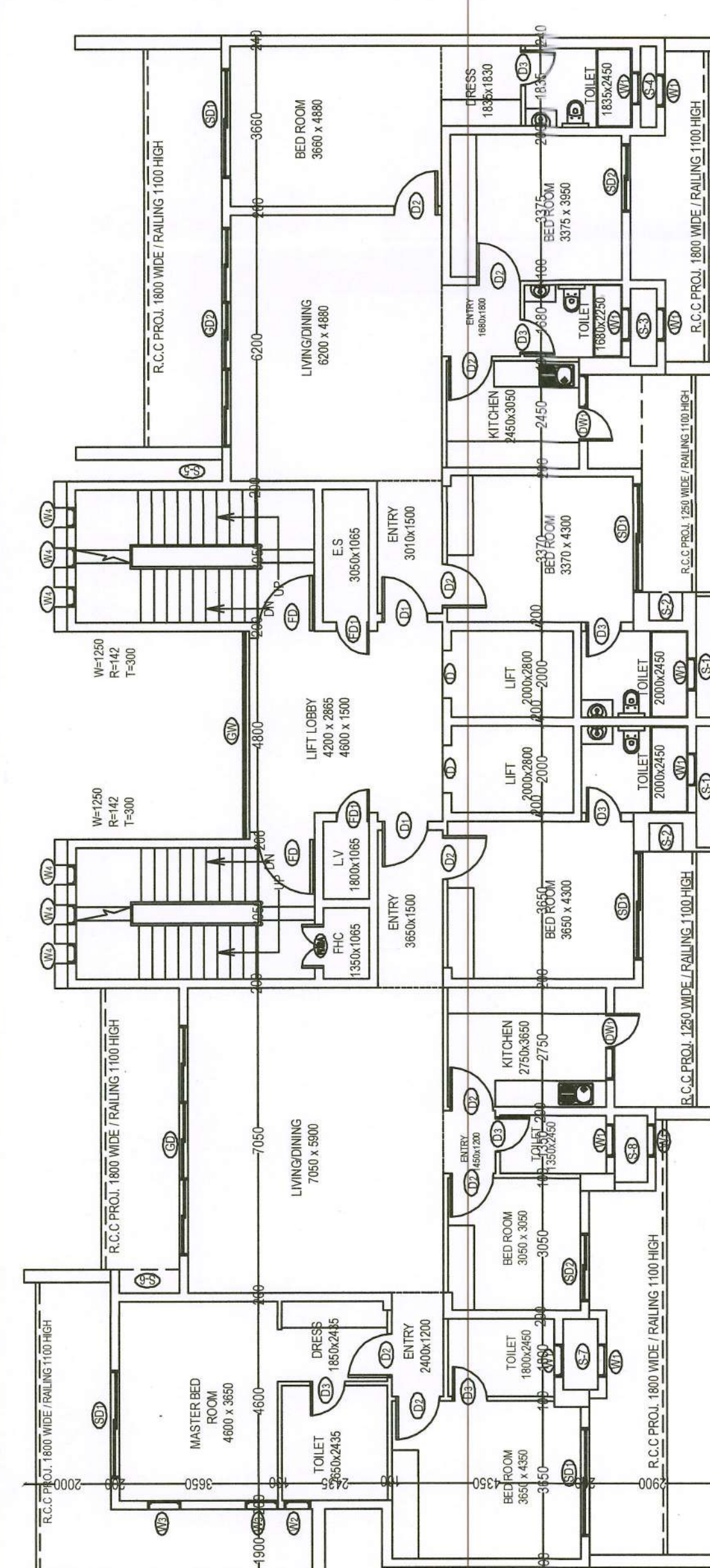
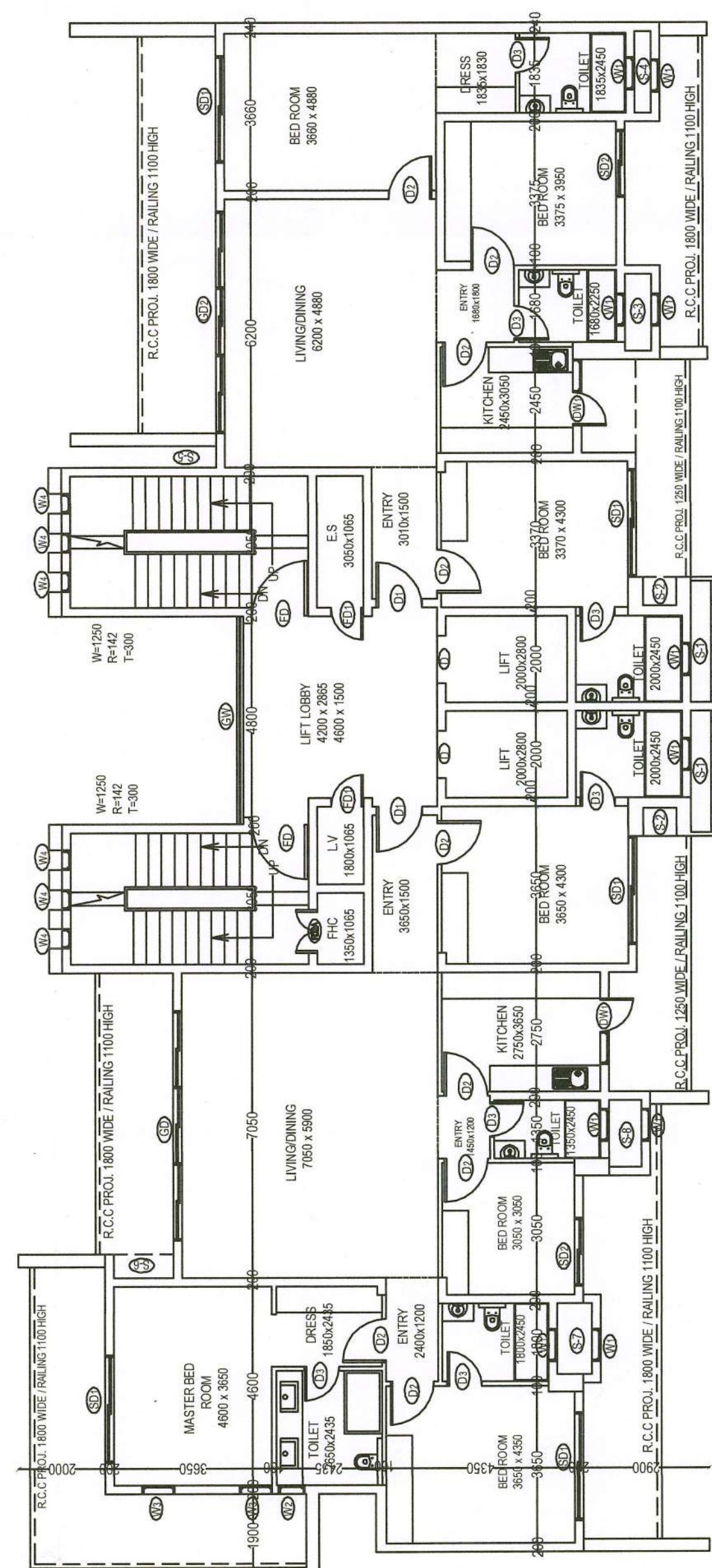
THIRTEENTH ELOOR PLAN
