Affidavit-cum-Declaration

Affidavit cum Declaration of Mr. Sandeep Gulati, Authorized Signatory of M/s Lotus Trading and Securities Pvt. 1. That the promoter has a legal title to the land on which the development of the project is proposed.
2. That the said land is free from all encumbrances.
3. That the time period within which the project shall be completed by the promoter is **31.12.2028**.
4. That seventy percent of the amounts realized by the Promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
