

#### Affidavit-cum-Declaration

Affidavit cum Declaration of Mr. Sandeep Gulati, Authorized Signatory of M/s Lotus Trading and Securities Pvt. - 1. That the promoter has a legal title to the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.
- **3.** That the time period within which the project shall be completed by the promoter is **31.12.2028.**
- 4. That seventy percent of the amounts realized by the Promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
