  - b) That the conditions of the agreement already executed are duly fulfilled and the provisions of Haryana Development and Regulation of Urban Areas Act ,1975 and the Rules, 1976 made thereunder are duly complied with.
  - c) That the demarcation plan of the I.T. Park area is submitted before starting the development works in the colony and for the approval of zoning plan.
  - d) The commercial/shopping area shall not exceed 4% with 150 FAR.
    - In case of misuse of space/violation of area restriction, penalty may be imposed on the licencee for the entire area sold/leased out by the licencee to the entrepreneur in the form of licence fee, conversion charges at the commercial rate along with any other penalty to be decided by the Government which would be in the form of additional conversion charges at commercial rates on the portion of the FAR between 150 to 250 of the entire misused area of sold/leased out by the licencee to the defaulting entrepreneur.
  - e) The licencee shall complete at least 30% of the IT area within the initial period of three years, failing which he will have to deposit the conversion charges and licence fee at commercial rate for the entire IT area.
