## **Affidavit cum Declaration**

- 8. That [I/ the promoter] shall take all the pending approvals on time, from the competent authorities.
- 9. That [I/ the promoter] [have/ has] furnished such other documents as have been prescribed by the Act and rules and regulations made there under.
- 10. That [I/ the promoter] shall not discriminate against any Allottees at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
