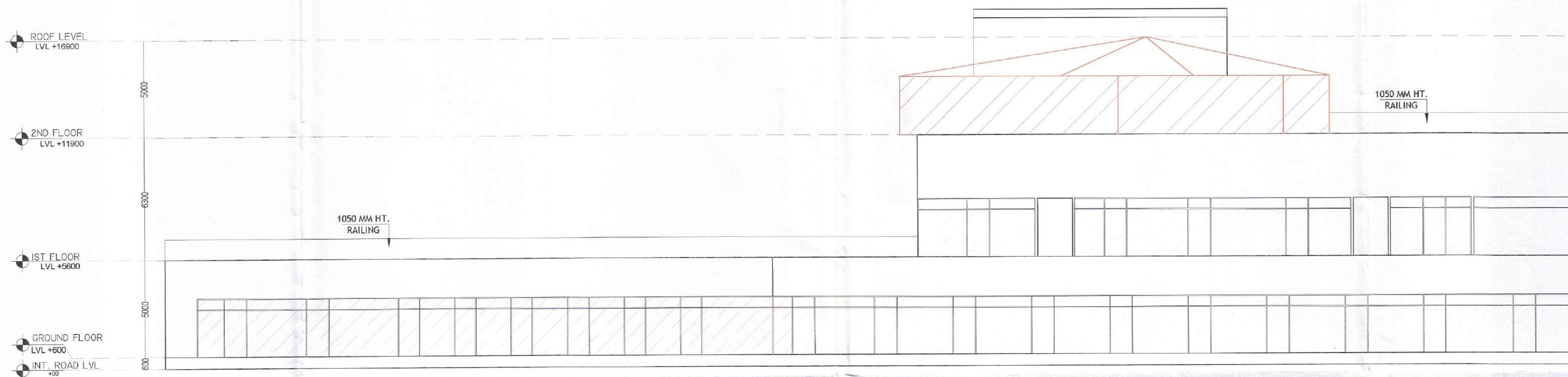
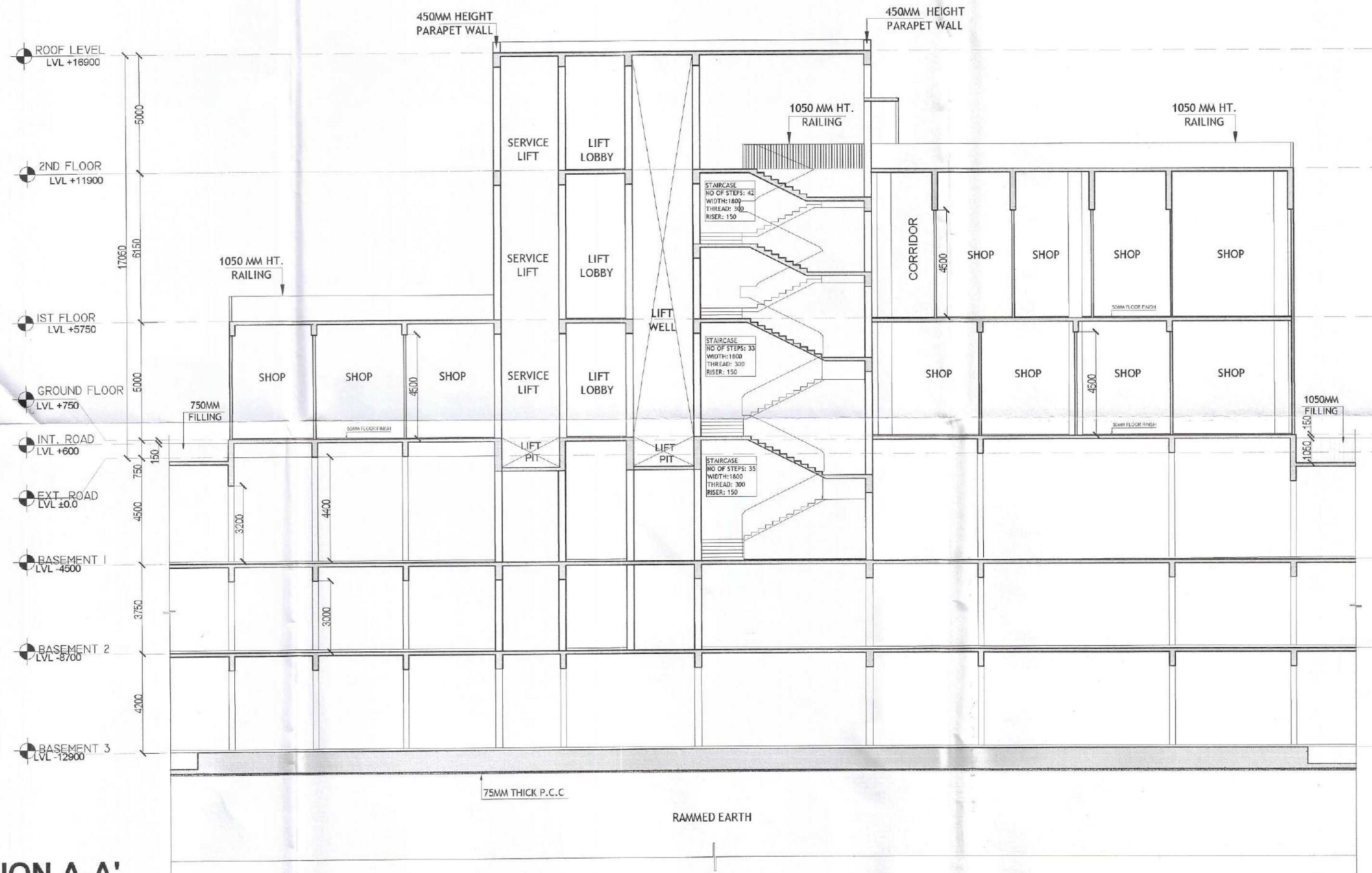


**ELEVATION A**  
SCALE 1:150

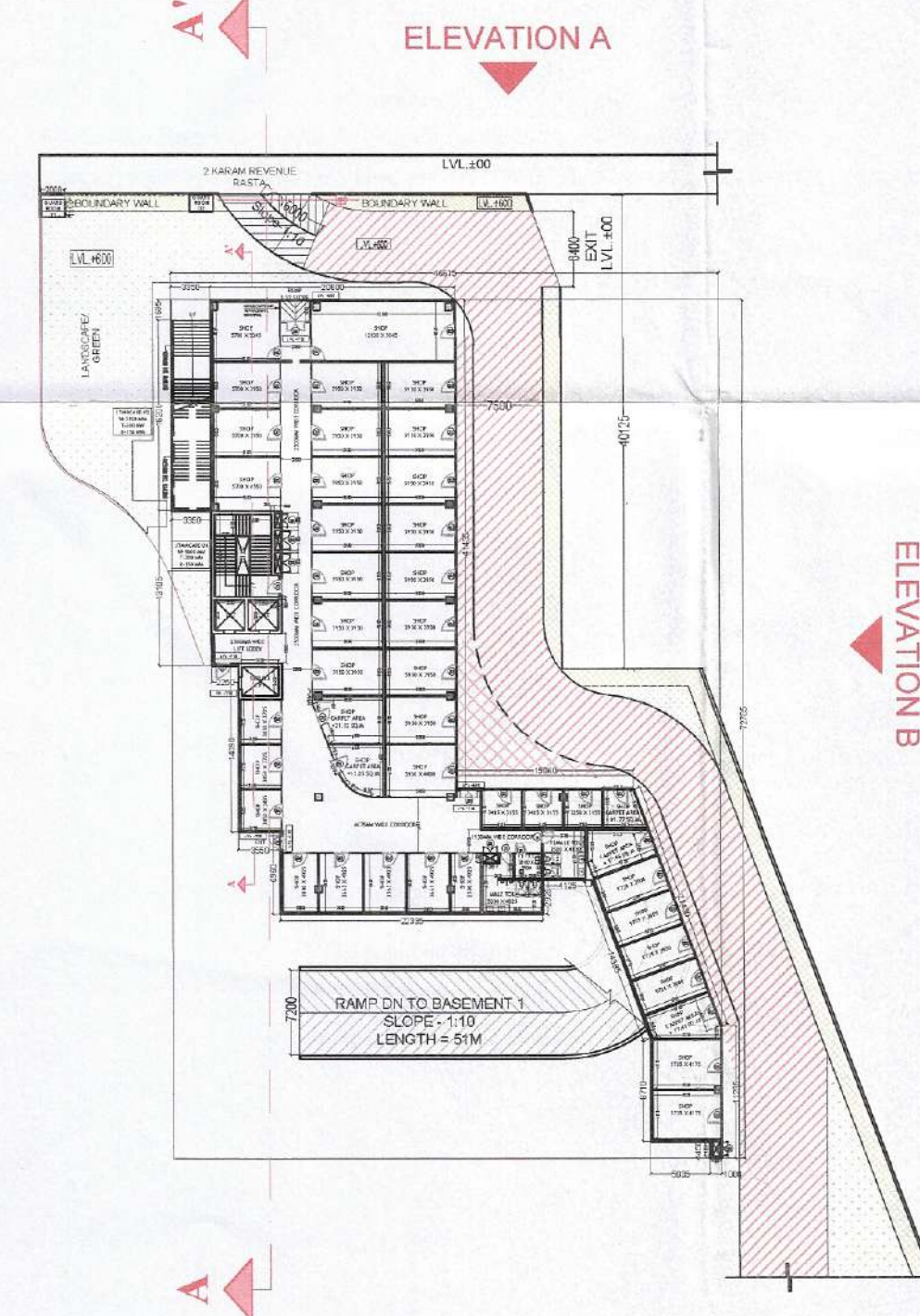


**ELEVATION B**
