That the promoter shall obtain Completion Certificate (CC) on or before 30/09/2028

That the time period within which the project shall be completed by promoter is 31/12/2028.

That seventy per cent of the amounts realized by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of Development and the land cost and shall be used only for that purpose.
