- 2. Whereas, the request of TDR Holder companies for transfer of TDR certificate no. 1-400 of 43/2024 dated 07.11.2024 in favour of H L Residency (Proprietor Shailja Joon W/o Rakesh Joon) has been considered as per the provision of TDR Policy dated 16.11.2021.
- 3. The application dated 12.11.2024 received from of H L Residency (Proprietor Shailja Joon W/o Rakesh Joon)for utilization of additional FAR of 48226.933 sqm against TDR certificate no. 1-400of 43/2024 on the Group Housing Component having area measuring 15.00 acres allotted by HSIIDC throughe-auction in Sector 30-B, Phase-III, IMT Rohtak was examined as per TDR policylated 16.11.2021 and inprinciple approval issued vide memo no. 36185 dated 25.11.2024 as an area measuring 48226.933 Sqm is found to be permissible FAR that can be availed on aforesaid site as per collector rate.
