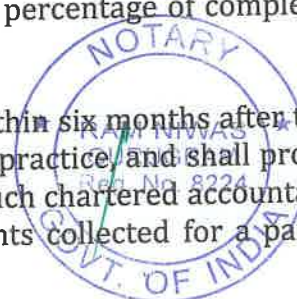
Affidavit cum Declaration

Affidavit cum Declaration of Ashok Kumar S/o Mr. Karan Singh R/o Jaurasi, Gurugram Haryana, India duly authorized by the promoter, **M/s NANI RESORTS AND FLORICULTURE PRIVATE LIMITED** of the project '**ROF PRAVASA**', vide its authorization dated 04.10.2024;

I, Ashok Kumar S/o Mr. Karan Singh R/o Jaurasi, Gurugram Haryana, do hereby solemnly declare, undertake and state as under:

1. That **M/s NANI RESORTS AND FLORICULTURE PRIVATE LIMITED** have a legal right and title to the land on which the development of the project is being carried out vide Mutation no 5305-5307-5308 and Vasika no.9552-9587-9421 Dated 03.03.2022,28.02.2022 enclosed herewith.
2. That there are no encumbrances over such land.
3. That the time period within which the project shall be completed by the Promoter is 30.12.2028.
4. That seventy per cent of the amounts realized by the promoter for "ROF PRAVASA" from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the Promoter in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular

project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter has furnished such other documents as have been prescribed by the Act and the draft rules and regulations made thereunder.
10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
