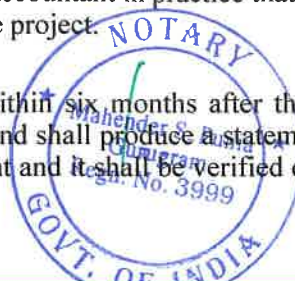
### DECLARATION, SUPPORTED BY AN AFFIDAVIT, WHICH SHALL BE SIGNED BY THE PROMOTER OR ANY PERSON AUTHORIZED BY THE PROMOTER

#### Affidavit cum Declaration

Affidavit cum Declaration of Mr. KK Sheera and Mr. Saurabh Choraria, duly authorized by the Promoter, vide its authorization dated 17.05.2024. The Promoter is in the process of developing a project namely 'Central 84, Sec 84' on land admeasuring 6.54 acres situated at Sector 84, Gurugram ("Said Land").

We, KK Sheera and Saurabh Choraria, Authorised Signatory (ies) of DLF Home Developers Limited, a Company incorporated under the provisions of Companies Act, 1956 and having its registered office at 2<sup>nd</sup> Floor, shopping mall, Arjun Marg, DLF City Phase I, Gurugram 122002 (hereinafter referred to as "**Promoter**") duly authorized by the Promoter of the proposed Project, do hereby solemnly declare, undertake and state as under:

1. That M/s DLF Home Developers Limited, has a legal title to the land on which the development of the proposed Project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and Promoter for development of the real estate project is enclosed herewith.
2. That the Said Land is free from all encumbrances.
3. That the time period within which the proposed Project shall be completed by Promoter is 30.06.2030.
4. That seventy per cent of the amounts realised by Promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the Promoter in proportion to the percentage of completion of the Project.
6. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That the Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit



that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.

8. That the Promoter shall take all the pending approvals on time, from the competent authorities.
9. That the Promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That the Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
