Applicant M/s. Krrish Realtynirman Pvt. Ltd, M/s IST Green Power Pvt. Ltd, M/s Global Estates Pvt. Ltd,406, 4TH Floor, Elegance Tower, 8, Jasola, District Center, New Delhi vide letter no. Nil dated 21.09.2011 made a request in connection with land measuring 12.368 Acres having Rect. No. 15 Killa No. 6, 13, 14, 15, 16, 17/1, 17/2, 18, 23, 24/1, 24/2, 25/1. Rect. No. 16 Killa No. 1. Rect. No. 26 Killa No. 2/2, 9, 10/1, 10/2, 11. Rect. No. 27 Killa No. 15/2, 16/1/1. Land located at village Gawal Pahari, Tehsil & District Gurgaon. Applicant made a proposal to use this land for Group Housing Purposes. In continuation of report submitted by RFO, Gurgaon vide Letter No 836-G dated 21.11.2011.

- As per record available above said land is not part of notified / closed area under IFA 1927/FCA1980/Specific section a) 4 & 5 of PLPA 1900/ WLPA1972/ or any other forest land.
- It is clarified that by the Notification No. S.O.121/PA.2/1900/S.4/97 dated 28th November, 1997, all revenue estate of b) Gurgaon District is notified u/s 4 of PLPA 1900 and S.O.113/PA.2/1900/S.3/97 dated 17th November, 1997 u/s 3 of PLPA. The area is however not recorded as forest in the Government record but felling of any tree is strictly prohibited without the permission of Divisional Forest Officer, Gurgaon.
- If approach is required from Protected Forests by the user agency, the clearance/regularization under Forest C) Conservation Act 1980 will be required. Without prior clearance from Forest Department, the use of Forest land for approach road is strictly prohibited.
- As per record with the Forest Department, Gurgaon, the area does not fall under Aravalli Project Plantation done by d) the Forest Department.
- All other statutory clearance mandated under the Environment Protection Act. 1986 or any other Act/order shall be e) obtained as applicable by the project proponents from the concerned authorities.
- The project proponent will not violate any Judicial Order/ Pronouncement issued by the Hon'ble Supreme Court/ High f) Courts.
- It is clarified that the Hon'ble Supreme Court has issued various judgment dated 06.05.02002, 29.10.2002, g) 16.12.2002, 18.03.2004 etc. pertaining to Aravalli region in Haryana. Since the proposed site falls within 5 Km. of Delhi boundary, Surajkund & Badkhal Lake the permission from the Mining Department, Department of Town & Country Planning Haryana and other appropriate authorities must be obtained who is under obligation to follow the directions in the various Hon'ble Supreme Court judgments while granting permission.
- Since the project site is falls in the area closed under General Section 4 of PLPA, 1900, in which felling of trees etc. h) prohibited without prior permission of competent authority. The project proponent shall not fell any tree from the site without prior permission of competent authority. Divisional Forest Officer,
