Provided always and it is hereby agreed that if the Owner/Developer shall commit any breach of the terms and conditions of this Agreement or violate any provisions of the Acts and/or rules, then and in any such case, and notwithstanding the waiver or any previous cause or right, the Director, may cancel the license granted to the Owner/Developer.
- 22. The stamp duty and registration charges on this deed shall be borne by the Owner/Developer.
- 23. That any other condition which the Director may think necessary in public interest imposed.
