

- Those details of encumbrances including details of any rights, title, interest, dues, litigation and name of any party in or over such land is annexed as Annexure-A.
- That the time period within which the project shall be completed by the promoter is 31 March 2029. The promoter shall obtain Occupation Certificate on or before is 30th June 2029 and Complrtion Certificate on or before 31th December 2029.
- That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used 4.
- That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project. 5.
- That the amounts from the separate account shall be withdrawn the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project. 6.
- That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the
