- (4) That the proposed date of completion of construction and development work for applying occupancy certificate shall be 31.10.2028;
- (5) That seventy per cent of the amounts realized by the Promoter for the real estate Project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose;
- (6) That the amounts from the separate account, to cover the cost of the Project, shall be withdrawn by the Promoter in proportion to the percentage of completion of the Project;
- (7) That the amounts from the separate account shall be withdrawn by the Promoter after it is certified by an engineer, an architect, and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the Project;
