- B. (hereinafter called as "Principal GPA"), As per the requirement of theAmendment to the Principal Agreement, the executantswish to make certain revisions to the General Power of Attorney dated 03/08/2023to modify certain terms and conditions in the Principal GPA and accordingly, the executants are executing this Addendum GPA to reduce the same into writing.

### NOW THEREFORE THIS ATTORNEY WITNESSES AS UNDER:

- I. That the executants do hereby amend the PrincipalGPA to the extent and manner herein after appearing effective from the execution of this Addendum GPA.
- II. Recital defining "Said Land" shall stand deleted in its entirety and be replaced with the following:

The Executant is the absolute owner of a parcel of Land admeasuring 7.2833 acres as per details provided in Schedule–I situated in Village Sidhrawali, Tehsil Manesar, District Gurugram, Haryana ("Said Land")".

III. That save and except the changes and modifications contained herein, all other clauses, terms and conditions of the Principal GPA shall remain unchanged, valid and continue to be binding on the executants and nothing contained herein shall change or alter in any manner whatsoever the validity, enforceability and interpretation of the Principal GPA. In case of any discrepancy between the Principal GPA and the Addendum GPA, the terms of the Addendum GPA shall prevail over the Principal GPA.


