3. That the promoter shall obtain Occupancy Certificate (OC) on or before 31/10/2026
4. That the time period within which the project shall be completed by promoter is 31/01/2027.
5. That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
6. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by M/s Signatureglobal Developers Private Limited in proportion to the percentage of completion of the project.

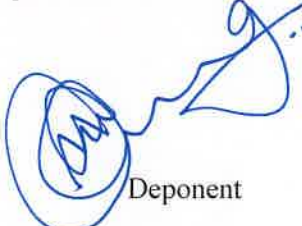
