Shifting of existing HVPNL 66kV D/C, EHT Sector-10 to Daultabad line of HVPNL passing from residential plotted in Eden Estate, Sector-102, Gurugram under self-execution scheme - Contractor Approval thereof.

Please refer to your office ref. no. NIL dated 06.01.2025 on the subject cited matter.

The request made by your office for approving the contractor to M/s Aquarian Enterprises for the work of shifting of existing 66kV D/C Sector-10 - Daultabad line of HVPNL passing from Your residential plotted in Eden Estate, Sector-102, Gurugram under self-execution scheme has been considered and approved subject to following stipulations as under:

- The administrative approval of the above said work has been accorded by worthy ACS Energy Haryana on dated 20.12.2024 and Worthy Managing Director HVPNL Panchkula on dated 18.12.2024 respectively vide XEN/TS Division Gurugram file No. CFMS 6229 dated 17.12.2024. The work is approved to be executed under self-execution scheme as per guidelines issued by Deputy Secretary / OP, HVPNL, Panchkula vide Memo No. Ch-17/DSO-214/L-154/L-2 dated 25.04.2012, Ch-237/DSO-513 dated 11.11.2021, Ch-24/DSO-522 dated 09.09.2024 and all other latest guidelines for self-execution scheme circulated time to time by the Nigam pertaining to the equipment/material to be installed will be complied in letter and spirit and required approval for the same will be obtained by M/s Aquarian Enterprises and M/S BPTP Limited from concerned offices of the Nigam as per guidelines for self-execution scheme. The material/equipment to be installed is also required to be got inspected through Nodal Officer of inspection (Deputy Secretary/Operation, HVPNL, Panchkula).
- It is to be ensured that M/s Aquarian Enterprises possess the Valid EHT-Class-A contractor license issued by Chief Electrical Inspector, Government of Haryana during the period of execution of the work. The contractor also possesses the valid ESI and EPF certificate and having similar work experience.
- The work may also be allowed to be executed as per HVPNL specifications and the drawing approved by CE/PD&C, HVPNL, Panchkula.
- 4. The required departmental charges for supervision of the work, may be got deposited by M/s BPTP, Faridabad. The work may be allowed to be executed only after deposit of requisite supervision charges or other applicable charges to XEN/TS Division, HVPNL, Gurugram.
- The work will be carried out by M/s BPTP, Faridabad after obtaining necessary ROW/NOC from other agencies where it is proposed to be installed/carried out.
- M/s BPTP, Faridabad will be responsible for award of contract, payments and other contractual obligations.
- All labour and other statutory laws if and as applicable are to be observed by the contractor.
- If any loss or damage is caused to existing HVPNL installation by the contractor during course of execution of the work, the responsibility of loss or damage in total vest with M/s BPTP, Faridabad and M/s Aquarian Enterprises.
- 9. During the execution of the work, the safety of the manpower and the material is the responsibility of M/s BPTP, Faridabad and M/s Aquarian Enterprises and in the eventuality of any mishap during execution of the work, HVPNL shall not be held responsible. Any indemnity bond for the same may be obtained from M/s BPTP, Faridabad and M/s Aquarian Enterprises by XEN / TS Division, HVPNL, Gurugram.

- On completion of the work, the site is to be got cleared by the contractor. All the surplus construction material, debris and T&P etc. is also required to be removed by the contractor.
- The dismantled material is to be properly accounted by the Committee of 2 SDOs and one Accountant already formed for TS Circle, Gurugram, dismantled material is to be returned to HVPNL's Store by the contractor.
- 12. It is clarified that for the contract between M/s BPTP, Faridabad and M/s Aquarian Enterprises, HVPNL will have no role and responsibility for any of the issue or dispute between them owing to their understanding, contract agreement, to be entered in for the execution of the above subject work under self-execution scheme.
- The work will be allowed to be executed as per availability of shutdown and may be commissioned after clearance by CEI, Govt. of India.
- No sub-letting of work as such may be allowed.
