

Sir,

I am directed to refer to your letter No. Vatika Ambala/08/07 dated 28.07.08 on the above subject and to say that Air HQ has no objection from aviation angle for construction of 45 meters high residential housing colony at village Sarai Memmood, Sonda, Kanwali & Jandli forming part of Sector - 21, 22, 23 & 25, Dist. Ambala by M/s Vatika Ltd, subject to the following conditions:-


- a) Height of the building shall not exceed 45 meters.
- b) Standard obstruction lightings to be provided by the company. The lights shall be switched on during night and poor visibility.
- c) Periodic maintenance of obstruction lightings to be carried out by the company/society at regular intervals to keep them in visible/serviceable conditions.
- d) A garbage treatment plant shall be installed prior to the construction of residential apartment for the purpose of avoiding bird activity. The plant may be shown to the AOC/his nominated representative at AF Stn Ambala on installation.
- e) The commencement, completion of works and installation of obstruction lights shall be intimated to AOC, AF Stn Ambala.
- f) Required security clearance should be obtained through MHA/IB of the foreign Nationals/Indian representative employed/to be employed by the Company in India.

2. You are also requested to obtain No Objection from other concerned Government Organization/Agencies as required.
