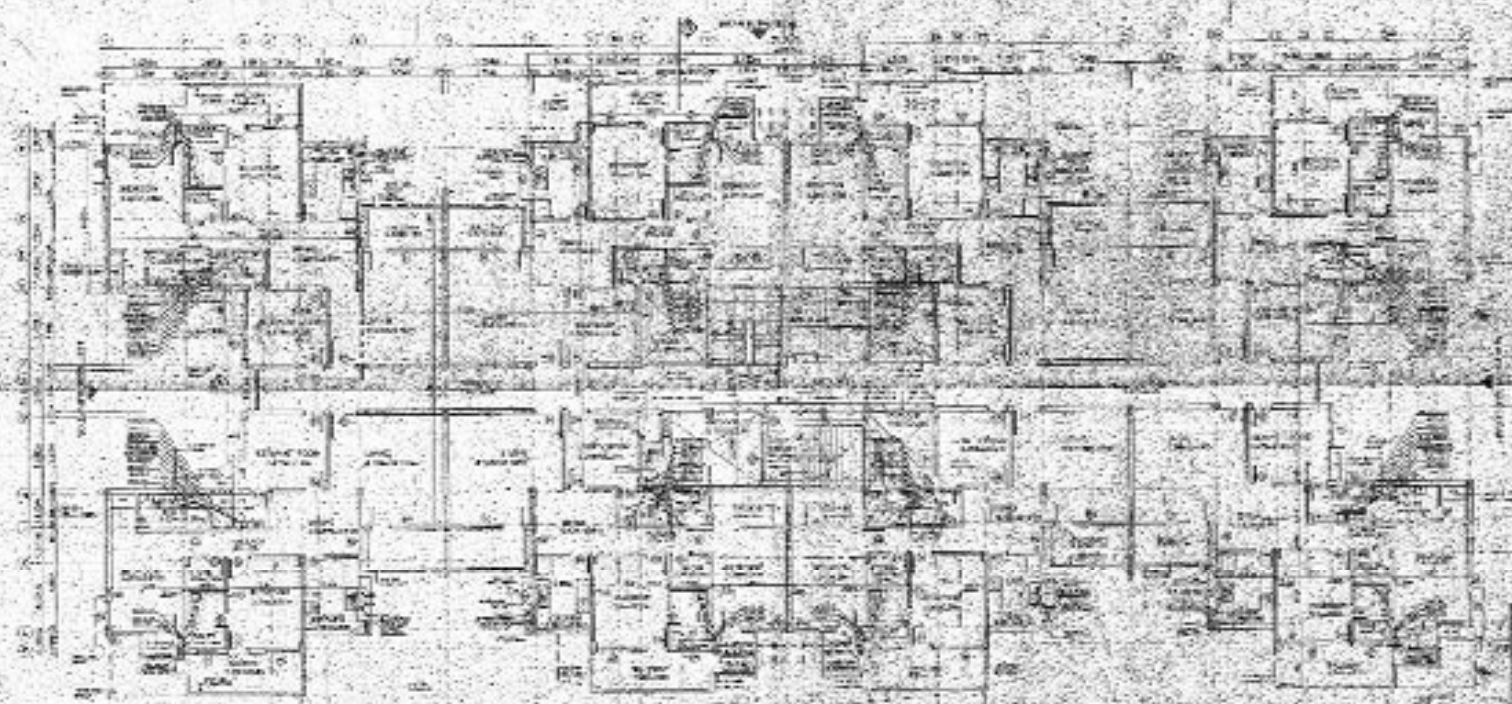

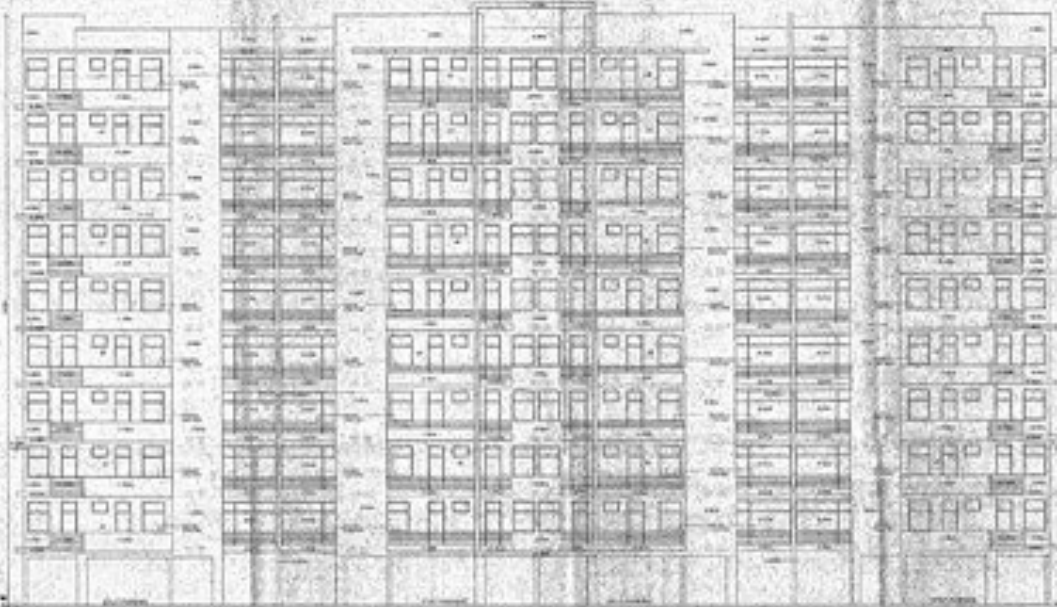


TYPICAL FLOOR PLAN

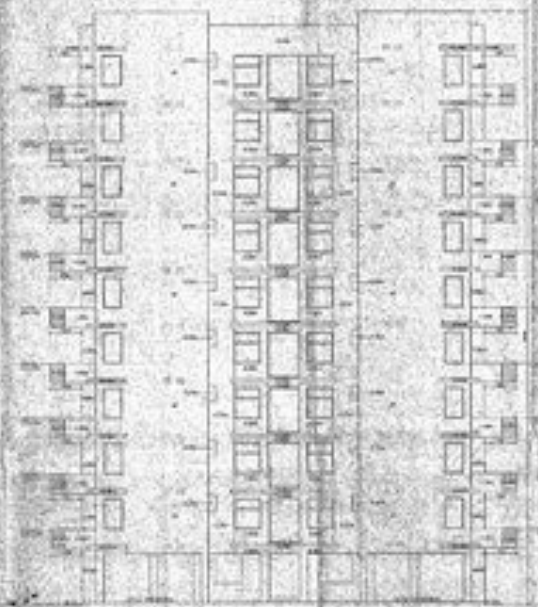

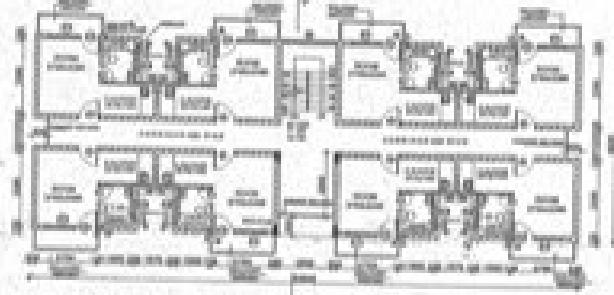
FRONT ELEVATION

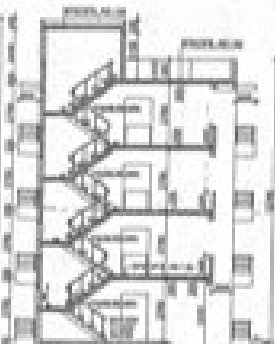
LEFT SIDE ELEVATION



TYPICAL FLOOR PLAN (1ST TO 6TH FLOOR)



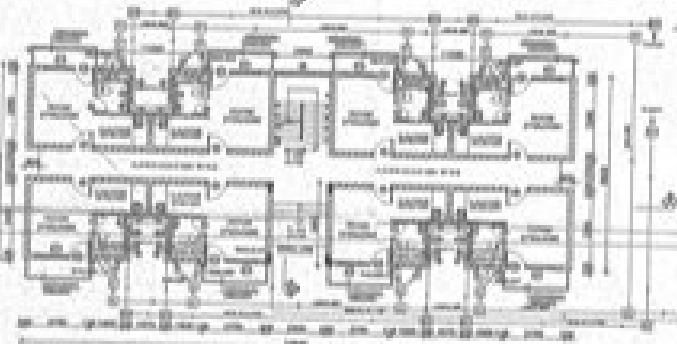
REAR ELEVATION

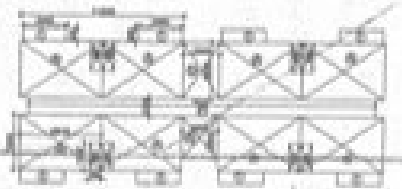
