

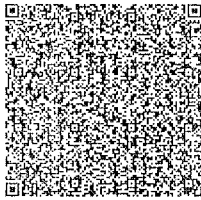

**Affidavit cum Declaration**

Affidavit cum Declaration of M/s Signatureglobal (India) Private Limited having its office at Unit No. 1304, 13th Floor Dr.Gopal Das Bhawan, 28 Barakhamba Road, New Delhi 110001 of the Proposed Affordable Group Housing Colony "Signature Global Prime" by Mr. Sanjay Kumar Varshney , Mr. Manish Garg & Mr. Ajay Kumar duly authorized by the promoter of the proposed project, vide its/his/their authorization dated 17<sup>th</sup> September, 2019.

We, Signatureglobal (India) Private Limited do hereby solemnly declare, undertake and state as under:

1. That M/s Signatureglobal (India) Private Limited has a legal title to the land admeasuring 5.00 acres on which the development of the project is proposed and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

3. That the time period within which the project shall be completed by promoter is 30/10/2023.
4. That seventy per cent of the amounts realised by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by M/s Signatureglobal (India) Private Limited in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn M/s Signatureglobal (India) Private Limited after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That M/s Signatureglobal (India) Private Limited shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a



statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.


8. That M/s Signatureglobal (India) Private Limited shall take all the pending approvals on time, from the competent authorities.
9. That M/s Signatureglobal (India) Private Limited has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
