As the site is located at a distance of 31046 m from the Aerodrome reference point of Safdarjung Airport airport, the NOC for height clearance is not required from Airports Authority of India as per GSR 751(E).

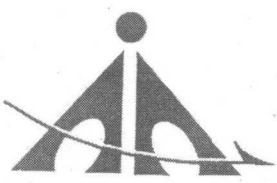
