AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of Mr. Chitranjan Saproo, Promoter of the proposed project / duly authorized by the promoter of the proposed project, vide its/his/their authorization;

- I, Chitranjan_[Promoter of the proposed project / duly authorized by the promoter of the proposed project] do hereby solemnly declare, undertake and state as under:
- 1. That [I / promoter] [have / has] a legal title to the land on which the development of the project is proposed
- 2. That the said land is free from all encumbrances except for construction loan facility availed by Promoter as mentioned in the REP-I.
- 3. That the construction of the said project is complete and Occupation Certificate has been received by the Promoter on 24.1.2019.

That the promoter has been depositing the seventy per cent of the amounts realised by [me/promoter] for the real estate project from the Allottees, from time to time, were being deposited in a separate account maintained in a scheduled bank to cover the cost of construction and the land cost prior to obtaining the OC and were used only for that purpose.

- 6. That the amounts from the separate account shall be withdrawn [met the promoter] after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That [I / the promoter] shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That [I/ the promoter] have taken all the pending approvals on time, from the competent authorities.
- 9. That [I/ the promoter] [have/ has] furnished such other documents as



have been prescribed by the Act and the rules and regulations made thereunder.

10. That [I / the promoter] shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion.
