Sub: Permission for crossing GAIL's Natural Gas Pipeline

Sir,

This is in reference to your letter dated 08.03.2022 & received on 22.03.2022 and joint inspection reports dated 29.03.2022 on the above subject pipeline crossing permission for laying its Utility Lines & Cable through zoom size cement pipe at one location by above the GAIL pipeline and above the ground (No Excavation in ROU) as detailed below:-

Permission is subjected to the terms and conditions of the agreement signed with GAIL and following terms & conditions:-

1. That the angle of intersection at crossing should be as near to 90o as practicable.
2. **The clearance between M/s Global Horizon Holdings Private Limited Utility pipes & Cable through zoom size cement pipe above the GAIL pipeline and above the ground no excavation work on pipeline.**
3. Location of existing line shall be confirmed first by pipeline locator and then establish the exact location of the GAIL's pipeline crossing by opening trial pit manually at crossing location.
4. As built drawing of the crossing by superimposing on GAIL's existing pipeline drawing or a new drawing as prescribed by GAIL should be submitted to GAIL after completion of the job.
5. After laying the Utility Lines & Cable through zoom size cement pipe, proper restoration and compacting will be done by M/s Global Horizon Holdings Private Limited. M/s Global Horizon Holdings Private Limited will also form a crest over the pipeline so as to avoid the possibility of depression. Back filling shall be done as per standard practice and to the satisfaction of authorized representative of GAIL.
6. M/s Global Horizon Holdings Private Limited has executed an agreement with GAIL on Non-Judicial stamp Paper of Rs 100/- before starting the work.
7. You have to furnish the photograph of the crossing site during the crossing and after the restoration for the refund of the S.D.
8. **Permission will be valid only up to the 18.06.2022 as the Insurance Policy submitted by you is expiring on dated 19.06.2022.**

9. Please insure that all the related work to this P/L crossing should be completed by 19.06.2022 in all respect. In case party is fail to execute the work within said time period, Party will applied for fresh permission for execution of same work. In case work is not completed within this period GAILs Pipe Line section has to be restored in its original position for the safety & integrity of P/L. If the party fail to restore to GAIL Pipe Line section same shall be restored by GAIL & expenditure shall be recovered from the submitted Security deposit amount.
10. It is one time Permission only for utility crossing. In future permission can not be Co-related with other work in ROU. In GAIL ROU any type of construction/plantation/execution/digging etc. are not allowed as per PMP act 1962.
11. Prior intimation shall be conveyed to GAIL well in advance for deputing GAIL's representative. Under no circumstances M/s Global Horizon Holdings Private Limited shall carry out the job without prior intimation to GAIL and without the presence of GAIL's representative.
12. The job shall be carried out in presence of authorized representative of M/s Global Horizon Holdings Private Limited.
13. GAIL shall have the right to excavate/repair gas pipeline without any prior information to M/s Global Horizon Holdings Private Limited.
14. M/s **Global Horizon Holdings Private Limited** has to take utmost care to protect GAIL's pipeline/OFC and any damage to the same if occurred, shall be repaired by M/s Global Horizon Holdings Private Limited as per GAIL's specification at their own cost within maximum 48 hours.
15. M/s Global Horizon Holdings Private Limited shall be held responsible for any damage occurred to GAIL's pipeline during the laying/subsequent repair of their OFC.
16. The permanent pipeline markers and warning sign board shall have to be provided at this location if required (to be decided by GAIL SIC) by M/s Global Horizon Holdings Private Limited.
17. Watch and Ward shall be provided during off work hour to avoid accident falling off in trench. Also work area shall be barricaded by yellow Danger tape and temporary markers.
18. If any maintenance job is carried out at this location by M/s Global Horizon Holdings Private Limited in future, separate permission shall have to be taken from GAIL.
19. No objection certificate from the landowner/farmers of ROU or from Govt. authorities like PWD, NHAI etc. shall be obtained and a copy of which shall be submitted to GAIL after complete restoration of ROU.
20. If GAIL pipeline/OFC is required to be lowered or re-routed due to soil erosion, inadequate land cover, upcoming other crossings (e.g. Highways etc.) in future, M/s Global Horizon Holdings Private Limited shall also re-route or lower its OFC at his own risk and cost as per GAIL instruction and/or revised drawing provided by GAIL.
21. M/s **Global Horizon Holdings Private Limited** shall prepare the contingency plan for safety of GAIL's pipeline in case of any eventuality during laying work and maintenance subsequently. The copy of the contingency plan shall be available at the crossing site.
22. All construction works shall be carried out in a manner so that the requirement of all relevant standards (PNGRB standard, OISD-226,214, PMP Act, API-1102, ANSI/ASME B31.4/B31.8 etc.) are complied.

You are requested to take necessary action as mentioned above and in the signed agreement for the pipeline crossing work.
