

## Engineer's Certificate

**Report for quarter ending** - **September'2019**

**Subject** - Certificate of percentage of completion of construction work of the project at the end of the quarter

I/we have undertaken assignment as engineer for certifying percentage of completion of construction work of the above-mentioned project as per the approved plans and approved structural drawings duly vetted by the proof consultant.

We have estimated the cost of the completion of the Civil, MEP and allied works, of the building(s) of the project/ phase for which occupation certificate/ completion certificate is to be obtained by the promoter. Our estimated cost calculations are based on the structural drawing/ plans made available to us for the project under reference by the developer and consultants and the schedule of items and quantity for the entire work as calculated by the quantity surveyor appointed by the developer/ engineer and the site inspection carried out by us.

The project estimated cost worked out as below. However all other project details are attached herewith

- Total estimated cost for completion of the building(s) in the aforesaid project under reference = Rs. 3615.11 Lacs
- Estimated cost incurred till date (based on site inspection) = Rs. 425.55 Lacs
- The balance cost of completion of the civil work/ MEP and allied works of the building(s) of the project for obtaining occupation certificate/ completion certificate from department of Town & Country Planning, Haryana = Rs. 3189.56 Lacs
