Our Estimated cost calculations are based on the drawings/ plans made available to us for the project under reference by the Developer and consultants and the schedule of items and quantity for the entire work as calculated by Shri Hari Om Rathi Quantity Surveyor appointed by Developer/ Engineer, and the assumption of the cost of materials, labour and other inputs made by developer, and the site inspection carried out by us.

We estimate TOTAL Estimated Cost of Completion of the aforesaid project under reference of Rs. 6607.30 Lakhs (As per Table A And B). The estimated Total Cost of Project is with reference to the Civil, MEP and allied works including land cost and other expenses like marketing & sales which are required to complete for the purpose of obtaining occupation certificate/ completion certificate for the project from the Directorate of Town & Country Planning - Haryana, being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.

The Estimated Cost Incurred till 30th September 2020 is calculated at Rs.29,07,20,248.66(as per Table A And Table B). The amount of estimated cost incurred is calculated on the base of amount of Total Estimated Cost.

The Balance Cost of Project is with reference to the Civil, MEP and allied works including land cost and other expenses like marketing & sales which are required to be completed for the purpose of obtaining occupation certificate/ completion certificate is Rs. 37,0009751.34 (as per TableA And Table B).
